Bladen Solar, LLC - CPCN and Registration Amendment

Dear Chief Clerk:

An application for certificate of public convenience and necessity for a 50.0-MW<sub>AC</sub> solar facility for Bladen Solar, LLC (Bladen) was filed on February 23, 2015 (the "Facility"). Due to siting constraints, the location of the facility has shifted and will impact additional land. The Applicant entered into site control agreements with Dogwood Creek Land Holdings ("Dogwood Creek"). Dogwood Creek has entered into an amended option to lease with Sally & Melvin Horner for additional acerage of one parcel, an option to purchase from Jose P. Budinich and Stave McKensie, the landowners of two additional parcels, and a letter of intent to lease with Milton G. Autry, the landowner of a third additional parcel. Under the site control agreements, Dogwood Creek agrees that it will exercise its rights under the agreements with the current landowners at the direction of Bladen, and authorizes Bladen the right to pursue development activities.

Enclosed and marked as Bladen Solar Amendment Exhibit 1 is an amended proposed layout. A revised location description is as follows:

Portions of the Facility will be located on both the east and west sides Old Fayetteville Road, east of the intersection with Walter West Road, in Fayetteville, Bladen County, North Carolina.

Due to the change of the site location, we understand the Commission will enter an Order Requiring Publication providing an amended Public Notice and directing the Clerk to forward the amended application to the Clearinghouse.
