Pursuant to the North Carolina Utilities Commission’s Order Establishing Additional Procedures for Expert Witness Hearing issued on February 21, 2024 (Order), the Public Staff hereby files this Errata Sheet showing corrections that should be made to the prefiled direct testimony and exhibits of witness David M. Williamson. The corrections are as follows:
