BY THE COMMISSION: On June 17, 2020, the Commission issued an Order Adopting Procedures for Expert Witness Hearings (Hearing Order), in the above-captioned dockets involving general rate case applications by Duke Energy Carolinas, LLC (DEC), and Duke Energy Progress, LLC (DEP). The Hearing Order, among other

things, scheduled a consolidated expert witness hearing to commence on July 27, 2020, for the purpose of considering testimony on topics for which the evidence is identical in both the DEC and DEP cases, to be followed by a separate DEC hearing commencing on August 4, 2020, to consider the remaining DEC issues, to be immediately followed by a separate hearing in DEP's rate case to consider the remaining DEP issues.

On July 2, 2020, DEC and DEP (collectively Duke), filed a Joint Motion to Excuse Witnesses from Attending Evidentiary Hearing. In summary, Duke stated that all parties have agreed to waive cross-examination of the witnesses designated below for the consolidated and separate hearings, except where otherwise noted, and that the parties on behalf of whom the designated witnesses filed testimony authorized Duke to file a motion requesting that their witnesses be excused from testifying.

On July 9, 2020, the Commission issued an Order Accepting Recommended Consolidated Issues for Remote Expert Witness Hearing and Postponing Separate Issue

Hearings (Consolidated Hearing Order). The Consolidated Hearing Order identified the topics to be addressed by expert witness testimony in the consolidated DEC/DEP hearing to be held remotely beginning on July 27, 2020, and postponed the previously scheduled separate hearings on DEC's and DEP's applications until a date certain to be set by subsequent order.

Based on Duke's motion and the records in these dockets, the Commission finds good cause to excuse the witnesses designated above from testifying at the consolidated expert witness hearing in these dockets that is scheduled to begin on July 27, 2020, and from testifying at the separate DEC and DEP hearings to be scheduled, except for witnesses John Hinton and Kurt Strunk, who will be required to appear and testify in the consolidated hearing. Further, the Commission finds good cause to admit into evidence at the hearings the testimony and exhibits of the excused witnesses designated above.

IT IS, THEREFORE, SO ORDERED.
