In support of its motion, Bald Head Association states:

1. On December 14, 2022 the prefiled direct testimony and exhibits of Robert Drumheller were submitted on behalf of Bald Head Association in this docket.
2. In the meantime the Commission has issued its decision in Docket No. A-41, Sub 21, and substantial additional testimony and exhibits have been submitted on behalf of other participants in this docket addressing in detail the topics addressed in the Drumheller testimony.

As a result, the Association requests that Mr. Drumheller's testimony and exhibits be withdrawn, that Mr. Drumheller be excused from formal sponsorship of prefiled testimony and exhibits at the March 7, 2023 hearing and that the Association's further participation in this docket, if any, be limited to post hearing filings.

4. Accordingly, Bald Head Association respectfully requests through its undersigned counsel that the Commission enter an order allowing the withdrawal of Mr. Drumheller's testimony and exhibits.
