NOW COME Duke Energy Carolinas, LLC (“DEC”), and Duke Energy Progress, LLC (“DEP”) (collectively, the “Companies”), by and through counsel, to respectfully request that the North Carolina Utilities Commission (“Commission”) extend the deadline set forth in the Commission’s January 17, 2024, *Order Scheduling Public Hearings, Establishing Interventions and Testimony Due Dates and Discovery Guidelines, Requiring Public Notice, and Providing Direction Regarding Duke’s Supplemental Modeling* (“Scheduling Order”) for mailing of the Notice of Hearings from 30 days in advance of the first hearing to 20 days.

In support of this Motion, the Companies submit the following:

1. On January 17, 2024, the Commission issued the Scheduling Order requiring notice of the public hearings to be provided through newspaper publication, website notification, email, and through “mail to each of their customers...no later than 30 days in advance of the first hearing ...”
2. The Companies have commenced with compliance efforts related to these notice requirements and are on track to complete all items in a timely matter.

3. Due to the timing of the Companies' billing cycle, completing notice by mail 30 days in advance of the first public hearing would require a separate mailing that would cost several hundred thousand dollars.


4. However, the Companies could complete notice by mail through the ordinary billing process at a fraction of that cost, with all such mailings being completed 20 days in advance of the first public hearing.

5. Therefore, the Companies respectfully request that the Commission amend its Ordering Paragraph No. 8 of the Scheduling Order to change the notice requirement for mailings from "30 days in advance of the first hearing" to "20 days in advance of the first hearing."

6. No parties will be prejudiced by this amendment and all customers will receive ample and timely notice of the public hearings through multiple channels as required by the Commission's Scheduling Order.

WHEREFORE, the Companies respectfully request an amendment to the publication date for the bill insert mailings of the Notice of Hearings from 30 days prior to the first hearing to 20 days prior to the first hearing.


