NOW COMES the Public Staff – North Carolina Utilities Commission, by and through its Executive Director, Christopher J. Ayers, and respectfully moves the North Carolina Utilities Commission (Commission) to extend the deadline to file proposed orders and briefs to December 7, 2022. In support of this motion, the Public Staff respectfully shows the Commission the following:

- 1. On November 29, 2021, Duke Energy Carolinas, LLC and Duke Energy Progress, LLC (collectively, Duke or the Companies) filed with the Commission a Joint Application for Approval of Revised Net Metering Tariffs (Joint Application) in Docket Nos. E-7, Sub 1214, E-2, Sub 1219, and E-2, Sub 1076, requesting that the Commission issue an order approving the Companies' proposed net energy metering tariffs for customers who submit applications on or after January 1, 2023.
- 2. On January 10, 2022, the Commission established this docket and issued an Order directing all parties to file comments addressing the Joint Application. Through various orders, the Commission recognized the interventions

of interested third parties, and the Commission received several rounds of comments on a number of contested issues related to Duke's proposed NEM tariffs.

- 3. On November 8, 2022, the Commission issued an Order directing all parties to file proposed orders and briefs on or before December 2, 2022.
- 4. On November 30, 2022, the Public Staff requested a 5-day extension of time to file proposed orders and briefs.
- 5. On December 1, 2022, the Commission issued an Order Granting Extension of Time to File Proposed Orders and Briefs, extending the deadline to December 7, 2022.
- 4. Due to the press of other ongoing dockets, the Public Staff requires a final extension of time to prepare its proposed order and briefs a in this docket.
- 5. The Public Staff therefore requests that the Commission grant an extension to and including December 16, 2022, for all parties to file proposed orders and briefs.
- 6. The Public Staff has contacted all parties in this docket, and none have opposed the motion.

WHEREFORE, the Public Staff respectfully requests that the Commission issue an order extending the deadline for filing proposed orders and briefs to and

including December 16, 2022.
