**JOINT MOTION FOR
MODIFICATION OF THE
PROCEDURAL SCHEDULE**

NOW COME Petitioner, Blue Ridge Electric Membership Corporation, (“BREMC”) and Respondent Charter Communications Properties LLC (“Charter” and, collectively with BREMC, the “Parties”), and move the Commission for entry of an Order modifying the procedural schedule in this matter. In support of this motion, the Parties show the Commission as follows:

1. On June 7, 2017, the Commission entered its Order Establishing Procedural Schedule in this case, establishing, among other things, certain deadlines for the Parties to propound discovery and to submit pre-filed direct, responsive, and rebuttal testimony in this matter, which the Commission amended in its Order Granting Motion for Leave to Amend Verified Petition and Denying Motion for Temporary Stay entered on September 27, 2017.

2. The Parties, in order to accommodate mutually-agreed dates for depositions of lay and expert witnesses in this matter and to allow one another appropriate time to respond to their respective filings, have agreed and request that the Commission enter an order modifying the procedural schedule as follows:

Action	Current Date	New Date
Deadline for BREMC to pre-file direct testimony	October 11, 2017	October 16, 2017
Deadline for Charter to pre-file responsive testimony	October 27, 2017	October 30, 2017
Deadline for BREMC to pre-file rebuttal testimony	November 1, 2017	November 6, 2017

3. BREMC and Charter represent that modification of the procedural schedule in the manner they have proposed will not delay or otherwise require rescheduling of the evidentiary hearing in this matter, which is currently scheduled for November 8, 2017.


