Pursuant to North Carolina General Statutes (“N.C.G.S.”) §§62-60 and 84-4.1 and Rule R1-22 of the North Carolina Utilities Commission’s (“Commission”) Rules of Practice and Procedure, Brian O. Beverly of the law firm of Young Moore & Henderson, P.A., and Alan R. Mr. Jenkins will continue to represent the Commercial Group in the above-captioned proceedings until the final determination thereof, unless permitted to withdraw sooner by order of the Commission. Mr. Jenkins was granted a limited admission to appear on behalf of the Commercial Group in the Duke Energy Carolinas 2009, 2011, 2013, 2017 and 2019 rate cases, Docket Nos. E-7, Sub 909, No. E-7, Sub 989, E-7, Sub 1026, E-7, Sub 1146, and E-7, Sub 1214 in the Duke/Progress Energy merger proceedings, Docket Nos. E-2, Sub 998 and E-7, Sub 986, and in the Progress Energy Carolinas 2012 and Duke Energy Progress 2017 and 2019 rate cases, Docket Nos. E-2, Sub 1023, E-2, Sub 1142, and E-2, Sub 1219.

service may be had in all matters connected with the legal proceedings, or any disciplinary matter with the same effect as if personally made on Mr. Jenkins.


7. Mr. Jenkins has not been disciplined by any court or lawyer regulatory organization nor has he had any *pro hac vice* revoked.
