Dear Mr. Lashua,

Per your request, I have reviewed your rate structure for Zemosa Acres. Currently, you are classified as "Commercial Inside (the City limits)" rate which is a flat \$5.41/1000 gallons. This is the same rate at which other similar entities such as your company within the City limits are charged.

By way of comparison, the "Residential Inside" rate consists of an increasing block rate as shown below:

\$5.36/1000 gallons (0-6000 gallons) \$6.97/1000 gallons (6001-8999 gallons) \$8.58/1000 gallons (9000+ gallons)

Thus, you are receiving the best available rate structure.
