Pursuant to decretal paragraph 5 of the Order Rescheduling Hearing and Establishing Additional Procedures issued in this proceeding on January 20, 2023, I am transmitting for filing in the above-referenced proceeding on behalf of the Bald Head Island Transportation, Inc.
