**COMMUNICATIONS***INTERCONNECTION AGREEMENTS AND AMENDMENT (Proffitt/Coxton)***Carolina Telephone and Telegraph Company LLC and Central Telephone Company d/b/a CenturyLink**

1. Docket Nos. P-7, Sub 1299, and P-10, Sub 912 – Agreement with Simwood Inc.

On February 28, 2022, Carolina Telephone and Telegraph Company LLC and Central Telephone Company d/b/a CenturyLink, and Simwood Inc. (collectively, the Parties) filed an interconnection agreement for Commission approval.

The Public Staff recommended that the agreement be approved.

It was moved and passed that the Public Staff's recommendation be adopted.

**Mebtel, Inc. d/b/a CenturyLink**

2. Docket No. P-35, Sub 157 – Agreement with Simwood Inc.

On February 28, 2022, Mebtel, Inc. d/b/a CenturyLink, and Simwood Inc. filed an interconnection agreement for Commission approval.

The Public Staff recommended that the agreement be approved.

It was moved and passed that the Public Staff's recommendation be adopted.

**BellSouth Telecommunications, LLC d/b/a AT&T North Carolina (AT&T)**

3. Docket No. P-55, Sub 1575 – Amendment to the interconnection agreement with Charter Fiberlink NC-CCO, LLC, approved on October 28, 2005.

On February 18, 2022, BellSouth Telecommunications, LLC d/b/a AT&T North Carolina, and Charter Fiberlink NC-CCO, LLC filed for Commission approval an amendment to their existing interconnection agreement, approved October 28, 2005.

The Public Staff recommended that the agreement be approved.

It was moved and passed that the Public Staff's recommendation be adopted.
