Pursuant to North Carolina General Statutes (“N.C. Gen. Stat.”) §§ 62-60 and 84-4.1 and Rule R1-22 of the North Carolina Utilities Commission (the “Commission”) Rules of Practice and Procedure, Joshua Warren Combs of Troutman Pepper Hamilton Sanders LLP respectfully requests the Commission to enter an order permitting him to practice *pro hac vice* before the Commission on behalf of Duke Energy Carolinas (the “Company”) in the above-captioned matter.

In support of this motion, Mr. Combs alleges and shows the following:

1. The above-captioned matter is a regulatory proceeding before the Commission governed by North Carolina public utility law.
2. The Company is a limited liability company, duly organized and existing under the laws of the State of North Carolina and is a public utility under the laws of North Carolina with operations subject to the jurisdiction of this Commission.
3. Mr. Combs is an attorney in good standing, licensed to practice law in the State of Georgia and will appear on behalf of the Company in the above-captioned proceeding.

5. Mr. Combs will, unless permitted to withdraw sooner by order of the Commission, continue to represent the Company in the above-captioned proceeding until the final determination thereof.

Mr. Combs has agreed to be subject to the order and is amenable to the disciplinary action and civil jurisdiction of the General Court of Justice and the North Carolina State Bar in all respects as if he were a regularly admitted and licensed member of the Bar of North Carolina in good standing.

7. The Bar of Georgia in which Mr. Combs is regularly admitted to practice, grants permission to members of the Bar of North Carolina in good standing to practice *pro hac vice* under circumstances similar to those authorized by N.C. Gen. Stat. § 84-4.1.

8. Mr. Combs, who is counsel for the Company, is associated for purposes of appearing before the Commission with Jack E. Jirak of Duke Energy, a resident of this state who is duly and legally permitted to practice in the General Court of Justice of North Carolina, upon which service may be had in all matters connected with the legal proceedings, or any disciplinary matter, with the same effect as if personally made on Mr. Combs.

9. Mr. Combs has not been disciplined by any court or lawyer regulatory organization, nor has he had *pro hac vice* privileges revoked.

10. The Statements required by N.C. Gen. Stat. § 84-4.1 are attached to this motion.

11. Upon the Commission's issuance of an order granting this Motion, the appropriate filing will be made to the North Carolina State Bar as required by N.C. Gen. Stat. § 84-4.1. At that time, Mr. Combs will also remit to the Commission the checks for the filing fees payable to the Administrative Office of the Courts and the North Carolina State Bar.

WHEREFORE, the Company respectfully requests that this Motion be granted, and that Joshua Warren Combs be allowed to appear before the Commission in this matter.






