(b)(1)(iii)

North 301 Solar, LLC (the applicant), which is owned 100% by O2 emc, LLC has an option to purchase the site with landowner Billy C. Eason.

(b)(2)(i)

The generating facility will be located in Halifax County, NC on US-301N, Enfield, NC 27823. The Facility is accessible via I-95 NE to N Carolina 481 toward Enfield. Continue onto NC-481 then turn left onto US-301 N. The Facility will be located on US-301 N on your right in 4.4 miles. A full page map with the location of the facility, major equipment and site boundaries is included as Application Exhibit 1.

(b)(3)(i)

The generating facility is one 20 MW (AC) solar photovoltaic (PV) array. Its source of power is sunlight.

(b)(3)(ii)



The generating facility will be comprised of approximately ninety-thousand (90,000) 310W solar PV modules (or equivalent) along with racking equipment, grounding equipment, roughly twenty (20) 1000kW inverters (or equivalent), transformers, monitoring equipment, safety equipment, and fencing. The facility transforms sunlight into electricity and will be interconnected to the existing Virginia Electric Power Company Transmission System.

(b)(3)(iii)

Solar is an intermittent energy source. The Facility is projected to have a maximum dependable capacity of Zero (0) MW and the facility's nameplate capacity is Twenty (20) MW AC.

(b)(3)(iv)

The projected date on which the facility will come on line is December 31st, 2016.

(b)(3)(v)

The applicant will interconnect to the Virginia Electric Power Company transmission system, and sell power into the PJM Interconnect network as a merchant seller and/or sell power to a third party under a bilateral power purchase agreement pursuant to a wholesale distribution agreement with PJM Interconnect.

(b)(3)(vi)

The applicant will interconnect to the into the PJM Interconnect system through the Virginia Electric Power Company transmission system.

(b)(3)(vii)

There are no arrangements for firm, non-firm or emergency generation

(b)(3)(viii)

The service life of the equipment is expected to be a minimum of thirty (30) years.

(b)(3)(ix)

The projected year one annual sales in kilowatt-hours of this facility are 38.4 million kWh. PJM Interconnect will read the meter for sales.

(b)(3)(x)

North 301 Solar, LLC will produce renewable energy certificates that are eligible for compliance with North Carolina's Renewable Energy and Energy Efficiency Portfolio Standard (REPS). File for Registration as a New Renewable Energy Facility concurrently, in subsequent pages.

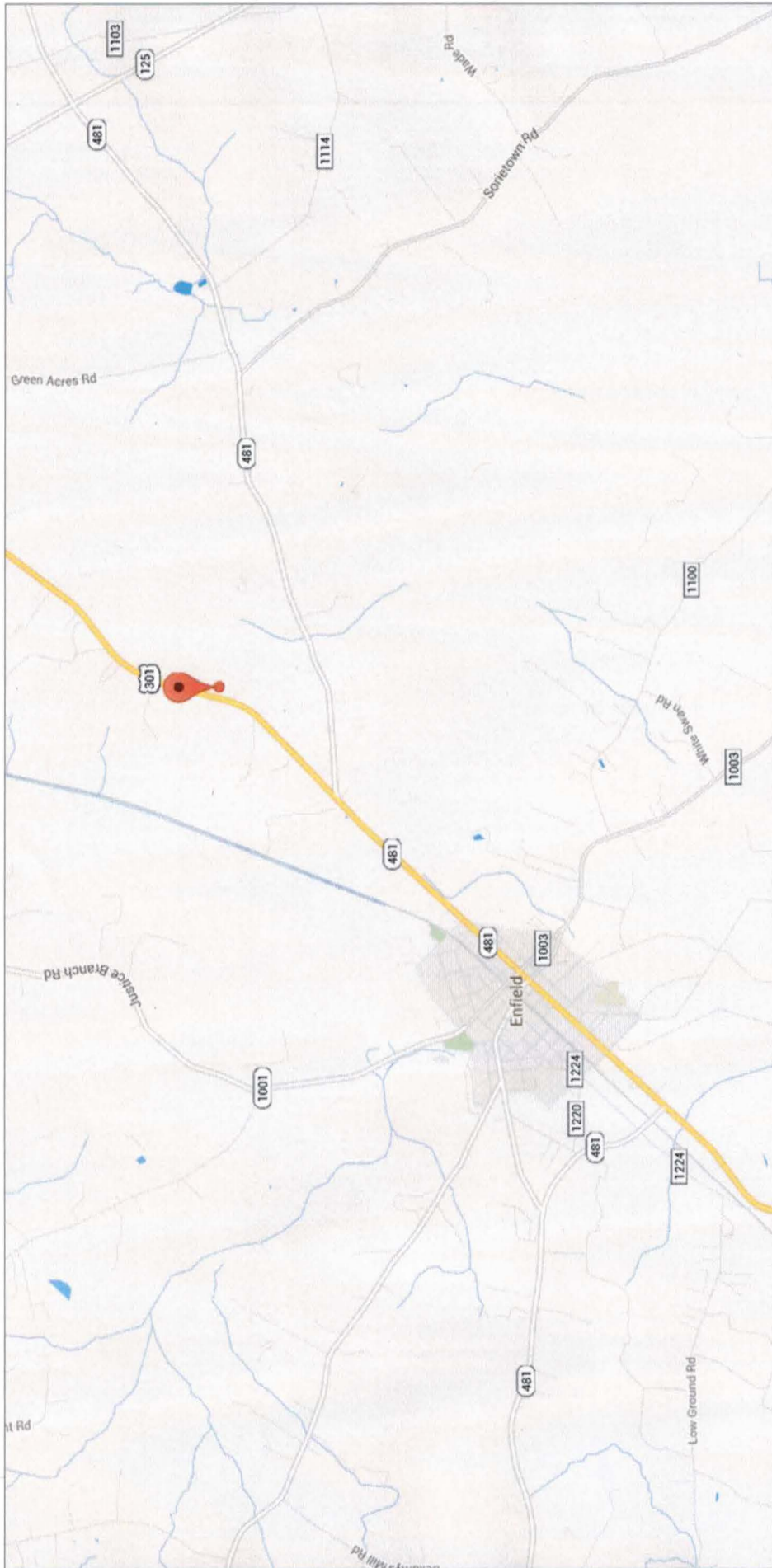

(b)(1)

The Applicant incorporates by reference each of the foregoing sections, including all subsections, in support of its Registration as a New Renewable Energy Facility.

(ix)

PJM Interconnect will read the energy production meter for the purpose of REC issuance.

(x)

The Applicant anticipates participating in the North Carolina Renewable Energy Tracking System (NC-RETS)

(b)(2)

The Applicant certifies that it is in substantial compliance with all federal and state laws, regulations, and rules for the protection of the environment and conservation of natural resources.

(b)(3)

The Applicant certifies that the facility satisfies the requirements of G.S. 62-133.8(a)(5) as a new renewable energy facility and that the facility will be operated as a new renewable energy facility.

(b)(4)

The Applicant certifies that the facility is not simultaneously under contract with NC GreenPower to sell RECs emanating from the same electricity production being tracked in NC-RETS; and any renewable energy certificates (whether or not bundled with electric power) sold to an electric power supplier to comply with G.S. 62-133.8 have not, and will not, be remarketed or otherwise resold for any other purpose, including another renewable energy portfolio standard or voluntary purchase of renewable energy certificates in North Carolina (such as NC GreenPower) or any other state or country, and that the electric power associated with the certificates will not be offered or sold with any representation that the power is bundled with renewable energy certificates.

(b)(5)

The Applicant certifies that it consents to the auditing of its books and records by the Public Staff insofar as those records relate to transactions with North Carolina electric power suppliers and agrees to provide the Public Staff and the Commission access to its books and records, wherever they are located, and to the facility.


