NOW COMES Gaston Green Acres Solar, LLC, (the "Applicant"), by and through its undersigned counsel, and herewith gives notice of a change of its legal name, and respectfully moves to amend the application and caption in this proceeding accordingly. In support of its motion, the Applicant shows unto the Commission the following:

1. On July 15, 2020, an application for a Certificate of Public Convenience and Necessity to construct a renewable electric merchant plant was filed pursuant to N.C.G.S. § 62-110.1 and NCUC Rule R8-63 on behalf of Gaston Green Acres Solar, LLC.
2. At the time the application was filed, the Applicant did not have a contract to sell the output of the proposed generation plant.
3. Since the filing of the application, the Applicant has entered into an out-take contract for the output of a portion of the proposed plant.
4. In connection with the making of the out-take contract, the counterparty requested that the Applicant change its legal name. The Applicant agreed to effect a change of name.
5. Attached hereto as Exhibit 1 is a true and correct copy of a filing made with the North Carolina Secretary of State to effect a change of name.
6. The current legal name of the Applicant is Oak Solar, LLC.
7. The application and caption in this proceeding should be amended to conform to the new legal name of the Applicant, Oak Solar LLC.
8. The Applicant has asked the Public Staff to consent to the amendment of the application and the docket caption as requested herein, but as of the time of the filing and service of this motion, has not received a response.

Wherefore, the Applicant originally named Gaston Green Acres Solar, LLC, herewith gives notice of a change of its legal name and requests that the application and caption in this proceeding be amended to reflect the new legal name of the Applicant, Oak Solar, LLC.



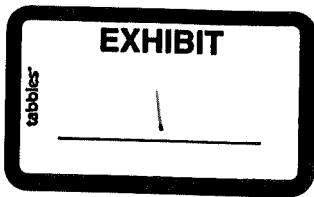
