Thank you for your email of August 13, 2021, concerning the above project. We apologize for the delay in our response and any inconvenience it may have caused.

The proposed solar installation boundaries are adjacent to the National Register-listed Shaw House (CK0008) property located east of Shawboro Road. As proposed, the project will have no adverse effect on historic property based on the following conditions being implemented.

- A mixed species, evergreen vegetative buffer or screen should be installed, specifically along boundaries adjacent to historic properties as it will serve to minimize the array's visual impact.
- For our records, photographs of the buffer adjacent to the historic properties must be provided once construction is completed.

Based on our knowledge of the area, it is unlikely that any archaeological resources that may be eligible for inclusion in the National Register of Historic Places will be affected by the project. We, therefore, recommend that no archaeological investigation be conducted in connection with this project.

The above comments are made pursuant to Section 106 of the National Historic Preservation Act and the Advisory Council on Historic Preservation's Regulations for Compliance with Section 106 codified at 36 CFR Part 800.
