RULES AND REGULATIONS

Item No. 20-B Ferry Schedules by Embarkation and Debarkation Points

Except as provided in Item No. 30, all ferries and trams will operate according to the schedules shown in Items No. 53, 54, 55, and 56 as long as there are passengers to be transported. Holiday Schedules and Additional Ferry Services are shown in Items No. 50 and 51, respectively. The Passenger Ferry and the Contractor Ferry will operate between Deep Point Marina in Southport, NC, and Bald Head Island, NC.

Item No. 30-B Operational Notices

Safe Operations

Bald Head Island Transportation, Inc. reserves the right to cancel service if the weather or sea conditions could be hazardous to safe operations or if there is an equipment malfunction.

Prearranged Service

All transport service is subject to the availability of ferry and tram capacity, on a first-come, first-served basis. Tram service is not guaranteed but is provided if seating capacity is available for those ticket classes where tram service is included. The number of trams scheduled for operation to support ferry runs is based upon anticipated ridership. Tram reservations made well in advance are recommended. Passengers without tram reservations will be allowed to ride an available tram on a first-come, first-served basis, secondary to reserved seating and subject to capacity restrictions.

Baggage Handling

The transfer of passenger baggage between the baggage racks and the ferry at Deep Point and Bald Head Island terminals on all ferry runs will be provided for passengers, excluding those passengers holding Class IV No Frills, Class V Contractor, and Class VI Employee tickets. All checked baggage must have a closed top (e.g., zipped, fastened, etc.) or affixed lid, such that its contents will not spill in transit.

CLASSIFICATIONS AND FARES

Item No. 40-D Fares and Charges

All fares are round trip unless otherwise indicated. The following fares include the utilization of the Bald Head Island tram service to and from the point of embarkation and debarkation, unless otherwise noted.

All passenger tickets are honored on the contractor ferry runs; that use does not need special identifiers/permissions on schedules the way Contractor ticket use of passenger ferries does. However, contractor ferry runs do not have baggage handling; passengers do retain tram privileges if their ticket qualifies for tram service.

A Fuel Surcharge may apply in addition to the fare prices shown below. Refer to Item 45 herein to determine if a Fuel Surcharge is applicable.

Tram service is not guaranteed but is provided if tram seating capacity is available. Tram reservations made well in advance are recommended.

Passengers are required to present a valid ticket before boarding on each leg of the round trip. Tickets are electronically scanned for validity and are limited to one round trip. Passengers not in possession of a valid ticket for the second leg of the round trip will be required to purchase a replacement ticket or a Class X One-Way to present for scanning before being allowed to board.

Class I – General Fare \$23.00

Applicable to all persons traveling to Bald Head Island from Southport when they DO NOT qualify for any other fare noted in this tariff. Tram service is not guaranteed but is provided if seating capacity is available. Tram reservations made well in advance are recommended.

Class II – Bulk 40 \$17.50

Available to persons or organizations who purchase packages of forty ferry tickets at one time. Tram service is not guaranteed but is provided if seating capacity is available. Tram reservations made well in advance are recommended.

Item No. 40-D (Cont.)

Class III - Bulk 80 **\$15.00**

Available to persons who purchase packages of eighty tickets at one time. A QR code, valid for eighty round trips and specific to each customer, is electronically generated and provided for printing or storage on the customer's mobile device, in lieu of using paper scan tickets. Tram service is not provided.

Class IV - No Frills **\$14.00**

Available for purchase only on Bald Head Island to persons living or staying on Bald Head Island. Tickets are valid only on the day of purchase for round trip transportation from Bald Head Island to Southport and return. No baggage or tram service is available with this ticket; parcels must be hand carried by the ticket holder.

Class V - Contractor **\$14.00**

Available to bona fide contractors traveling to the island to provide service on the island. Fare not available on Saturdays and Sundays. Contractor ferry must be used except as otherwise noted on the schedule. Tram and baggage services are not available. Contractors are allowed to ride the shuttle bus to and from the Contractor Service Village.

Class VI - Employee **\$14.00**

Available to bona fide employees of commercial and/or non-profit businesses located where that activity is not prohibited on Bald Head Island; also available to bona fide employees of governments and governmental agencies. Employees must be traveling in the course of their employment. Tram service and baggage handling are not included. Passengers holding this ticket will be allowed to board after all other fares have boarded, subject to ferry capacity restrictions.

Class VII – Children

Under age 3 years traveling with an adult.	\$ 0.00
Ages 3-12 years traveling with an adult	\$12.00

Tram service is not guaranteed but is provided if seating capacity is available. Tram reservations made well in advance are recommended.

Class VIII – Annual Pass **\$1,850.00**

Available only to persons whose primary residence is on Bald Head Island who are residential property owners of record or are persons leasing residential property. Baggage service is available; tram service is not included.

Class IX – Baggage

a. Oversized **\$23.00 (C)**

Applicable to each bicycle, or any other non-carry-on item too large (~ coolers larger than 48-quart size), too heavy (i.e., more than 50 pounds), or too cumbersome (i.e., cannot fit into a baggage dolly), or to items longer than seven (7) feet. This charge is in addition to the fare for transporting the person.

b. Excess **\$23.00 (A)**

Applicable to each checked item greater than the allowance as set forth below. This charge is in addition to the fare for transporting the person. No allowance shall be permitted on tickets purchased for the sole purpose of avoiding payment of Excess charges.

Every day throughout the year the allowance is three (3) checked items per passenger.

Items not checked as baggage must be suitable for transport on board by a single passenger and must not interfere with the comfort and safety of other passengers, in the judgment of BHI Transportation staff. Passengers may not carry on Oversized items as defined above.

Holiday Schedules

On Christmas Day, ferries will run a limited schedule. Ferries depart Deep Point at 9:00 a.m., 10:00 a.m., 5:00 p.m., and 6:00 p.m. Ferries depart Bald Head Island at 9:30 a.m., 10:45 a.m., 5:30 p.m., and 6:45 p.m. Tram service is not available to serve the 9:30 a.m. and 5:30 p.m. ferries. Tram service is available for the 10:45 a.m. and 6:45 p.m. ferry runs for passengers holding appropriate tickets.

On New Year's Day, Easter, Memorial Day, Fourth of July, Labor Day, and Thanksgiving Day, additional ferries may be added to the schedule if passenger volume merits.

Contractor ferry services are not offered on the weekday celebrating New Year's Day, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, the Friday after Thanksgiving, Christmas Eve, and Christmas Day.

Item No. 51

Additional Ferry Services

Additional ferry services may be offered in the evening from Bald Head Island on the half hour and from Deep Point on the hour to transport employees to and from Bald Head Island, if notice of need and reservations are made by said employees on the day of service. Other passengers holding appropriate tickets may utilize all ferries, without guarantee of tram service, if such ferries run.

Item No. 52-A

Shuttle Bus Service

Ground transportation via shuttle bus is offered between the Bald Head Island Ferry Terminal and the Contractor Service Village from Monday through Friday, excluding the holidays listed in Item No. 50. The shuttle bus departs from the Bald Head Island Ferry Terminal five (5) minutes after the arrival of the ferry providing contractor service. The shuttle bus departs the Contractor Service Village such that it will arrive before the scheduled departure of the ferry providing contractor service from the Bald Head Island Ferry Terminal.

Deep Point Parking

- \$12.00 - Daily General Lot Rate (overnight lot and no limit on length of stay);
- \$10.00 - Daily Contractor Lot Rate (no overnight parking permitted);
- \$1,400 - Annual Premium Lot Rate (overnight lot and no limit on length of stay);
- \$1,150 - Annual General Lot Rate (overnight lot and no limit on length of stay);
- \$700 - Annual Contractor Lot Rate (no overnight parking permitted);
- \$650 - Annual Employee Lot Rate (no overnight parking permitted - we do allow overnight parking given special, case-by-case circumstances in this lot);
- QR Code Exit Passes - Parking pass afforded to accommodate primarily Island-based businesses with seasonal or short-term employee needs. QR Code Exit Passes are \$6.00 per use-swipe to get out of a daily ticketed lot only (General Lot and Contractor Lot). QR Code Exit Passes are the responsibility of the businesses purchasing them and they are responsible for keeping track of their balances. Each business is given a code to go online to our website and view their balances.
- \$20.00 - Oversized Vehicle – Barge Landing Overnight-Oversized Parking - We charge an oversize rate of \$20.00 per day (this rate is based on a customer's vehicle taking up the equivalent of two standard-sized parking stalls). Barge Vehicle-Oversized Vehicles are parked in designated parking stalls located behind the Shipping & Receiving facility. All customers receive a tag to show they have paid before parking. This is the only parking area that we require prepayment before parking the customer. These spots are on a first come, first serve basis.

Please note that on a case-by-case basis, BHIL provides accommodation in the Employee Lot for employees who may have to stay overnight on occasion. Examples include the Conservancy, The BHI Club chefs who sometimes stay a few nights in a row, and employees of the Village who may need to stay on-island on occasion.

Charges for Barge Transport

Vehicle size determines the number of deck space tickets required. Lengths over an increment of six feet are assessed at the next six-foot increment.
