**NCSEA’S AMENDED MOTION TO WITHDRAW AND SUBSTITUTION OF

Pursuant to Rules R1-7, R1-22, and R1-23 of the Rules of the North Carolina Utilities Commission (“Commission”) and Rule R1.16 of the North Carolina State Bar Rules of Professional Conduct, on June 16, 2022 the North Carolina Sustainable Energy Association (“NCSEA”) filed NCSEA’s Notice of Withdrawal and Motion for Substitution of Counsel (“Motion”) regarding the withdrawal of Benjamin W. Smith as counsel of record for NCSEA in each of the above-captioned dockets, effective Friday, June 17, 2022, and the substitution of Taylor M.
