BY THE PRESIDING COMMISSIONER: On May 28, 2020, the Commission issued an Order Scheduling Hearing and Establishing Procedural Schedule on Remand in the above-captioned proceeding scheduling an expert witness hearing for Tuesday, November 24, 2020, and establishing deadlines for parties to file direct and rebuttal testimony.

On August 2, 2020, Cube Yadkin Generation, LLC (Complainant), Duke Energy Progress, LLC, and Duke Energy Carolinas, LLC (Respondents; collectively, the Parties), filed a joint motion requesting that the Commission extend the procedural schedule by approximately 60 days. The Parties request that the direct testimony and exhibits of Complainant be due on or before Tuesday, November 10, 2020, that the direct testimony and exhibits of Respondents be due on or before Thursday, December 10, 2020 and that Complainant's rebuttal testimony and exhibits be due on or before Tuesday, January 12, 2021. The Parties further request that the hearing be rescheduled to begin no sooner than Tuesday, January 26, 2021.

The Presiding Commissioner finds good cause to grant the requested extension of time for the Parties to prefile testimony and exhibits and to reschedule the hearing.

IT IS, THEREFORE, ORDERED as follows:

1. That the hearing solely for the purpose of receiving the expert witness testimony of the parties currently scheduled for November 24, 2020, shall be rescheduled to begin on Tuesday, January 26, 2021, at 10:00 a.m., and will be held either remotely via Webex or in Commission Hearing Room 2115, Dobbs Building, 430 North Salisbury Street, Raleigh, North Carolina. The Commission will issue a subsequent order setting

forth the procedures for a remote expert witness hearing or confirming that the expert witness hearing will be held in the Commission's Hearing Room;

2. That Complainant shall file its direct testimony and exhibits no later than Tuesday, November 10, 2020;


3. That Respondents shall file their direct testimony and exhibits no later than Tuesday, December 10, 2020; and

4. That Complainant may file rebuttal testimony and exhibits, if any, no later than Tuesday, January 12, 2021.
