P1. <u>APPLICATIONS FOR CERTIFICATES OF PUBLIC CONVENIENCE AND NECESSITY TO CONSTRUCT SOLAR FACILITIES</u>

EXPLANATION: The following applications regard certificates of public convenience and necessity for construction of solar photovoltaic (PV) generating facilities, pursuant to N.C. Gen. Stat. § 62-110.1 and Commission Rule R8-64.

Duke Energy Carolinas, LLC:

<u>Docket No. SP-8761, Sub 0</u> – Application of West River Solar, LLC, for renewal
of a certificate of public convenience and necessity to construct a 40-MW solar
PV facility in Guilford County, North Carolina. The applicant informed the Public
Staff that construction of the facility is expected to begin on January 1, 2023
(registration statement accepted previously).

Duke Energy Progress, LLC:

- <u>Docket No. SP-4661, Sub 0</u> Application of Thigpen Farms Solar, LLC, for renewal of a certificate of public convenience and necessity to construct a 4.99-MW solar PV facility in Robeson County, North Carolina (registration statement accepted previously). The applicant stated in its Motion to Renew that it expects to begin construction of the Facility in 2021.
- <u>Docket No. SP-8056, Sub 0</u> Application of Homer Solar, LLC, for renewal of a certificate of public convenience and necessity to construct a 70.2-MW solar PV facility in Richmond and Montgomery Counties, North Carolina (registration statement accepted previously). The applicant stated in its Motion to Renew that it expects the facility to be placed in service by December 21, 2025.

Dominion Energy North Carolina:

 <u>Docket No. SP-4900, Sub 0</u> – Application of Fresh Air Energy XXXVII, LLC, for renewal of a certificate of public convenience and necessity to construct a 19.99-MW solar PV facility in Northampton County, North Carolina. The applicant informed the Public Staff that construction of the facility is expected to begin soon after the renewal request is approved (registration statement accepted previously). The Public Staff has reviewed the applications and determined that they comply with the requirements of N.C.G.S. § 62-110.1 and Commission Rule R8-64.

RECOMMENDATION: (Metz/Lawrence/Saillor) That the Commission issue orders approving the applications and issuing the requested certificates. The Public Staff has provided proposed orders to the Commission Staff.

E. <u>WATER</u>

P1. <u>DOCKET NO. W-218, SUB 538 – AQUA NORTH CAROLINA, INC. – NOTIFICATION OF INTENTION TO BEGIN OPERATIONS IN CONTIGUOUS SERVICE AREA</u>

EXPLANATION: On October 5, 2020, Aqua North Carolina, Inc. (Aqua), filed a Notification of Intention to Begin Operations in Area Contiguous to Present Service Area (Notification) to provide water utility service in The Manors at Waterstone Reserve subdivision in Wake County, North Carolina. The Manors at Waterstone Reserve is contiguous to Aqua's Waterstone Reserve service area. On October 9, 2020, Aqua filed an amendment to the Notification. On September 1, 2021, and December 9, 2021, Aqua filed additional required exhibits. Aqua proposes to charge the rates currently approved for its other franchised service areas. The service area is shown on plans filed with the Notification.

The North Carolina Department of Environmental Quality, Division of Water Resources, Public Water Supply Section, issued a plan approval letter for The Manors at Waterstone Reserve, part of Water System No. NC4092136. The plans are approved under serial number 20-00754, by letter dated November 6, 2020.

Aqua entered into a Water Utility System Agreement dated September 8, 2020 (Agreement), with Waterstone Partners, LLC (Developer), under which Developer is installing the water utility system. Aqua is purchasing the water system from Developer for \$700 per single-family residential equivalent (SFRE), payable quarterly basis on the number of SFREs connected during the previous quarter. Aqua is requesting a meter installation fee of \$70 for water service, to be paid one time by the builder or person first requesting service to a particular lot. Aqua is to pay the Developer \$1,200 per well towards costs associated with well testing.

Aqua presently holds water franchises serving approximately 82,000 customers and sewer franchises serving approximately 20,000 customers throughout North Carolina. Aqua's record of service is satisfactory.

Agua has filed all required exhibits with the Notification.

Based on the foregoing, the Public Staff is of the opinion that Aqua has the technical, managerial, and financial capacity to provide water utility service in this contiguous area and recommends that the contiguous extension be recognized. The Public Staff further recommends that the Commission require posting of a \$10,000 bond for the contiguous extension. Aqua currently has \$13,000,000 of bonds posted with the Commission, which includes sufficient unassigned funds to provide the bond recommended in this docket.

RECOMMENDATION: (Junis/Chiu/Jost) That the Commission issue the proposed order recognizing the contiguous extension and approving rates.

P2. <u>DOCKET NO. W-1250, SUB 8 - SAXAPAHAW UTILITY COMPANY - SCHEDULING HEARING AND REQUIRING CUSTOMER NOTICE</u>

EXPLANATION: On October 18, 2021, Saxapahaw Utility Company (Applicant) filed an application with the Commission seeking authority to increase its rates for water utility service in the Village of Saxapahaw in Alamance County, North Carolina. The Applicant serves approximately 268 metered water customers. The present water rates have been effective since the issuance of the Commission's Order Granting Rate Increase and Requiring Customer Notice on September 17, 2019 in Docket No. W-1250, Sub 7.

On November 15, 2021, the Commission issued an Order Establishing General Rate Case and Suspending Rates.

The Commission concludes that the matter should be scheduled for public witness hearing for the sole purpose of receiving testimony from customers, subject to cancellation if no significant protests are received subsequent to customer notice; that the matter should be scheduled for an expert witness hearing for the sole purpose of receiving expert testimony from the Applicant, the Public Staff – North Carolina Utilities Commission, and intervenors, if any; and that the Applicant should be required to provide notice to its customers of the application, including the applied for rates and the scheduled hearings.

The customer hearing scheduled for February 15, 2022, will be held at 7:00 p.m. at the Alamance County Historic Courthouse, 1 Court Square, Courtroom #204 in Graham, North Carolina and the expert witness hearing scheduled for March 17, 2022, will be held at 10:00 a.m. at the Commission Hearing Room 2115, Dobbs Building, 430 North Salisbury Street in Raleigh, North Carolina.

The Public Staff recommends that the Commission issue an order scheduling hearings and requiring customer notice.

BY THE COMMISSION: On October 5, 2020, Aqua North Carolina, Inc. (Aqua), filed a Notification of Intention to Begin Operations in Area Contiguous to Present Service Area (Notification) to provide water utility service in The Manors at Waterstone Reserve subdivision in Wake County, North Carolina. The Manors at Waterstone Reserve is contiguous to Aqua's Waterstone Reserve service area. On October 9, 2020, Aqua filed an amendment to the Notification. On September 1, 2021, and December 9, 2021, Aqua filed additional required exhibits. Aqua proposes to charge the rates currently approved for its other franchised service areas.

The Public Staff presented this matter at the Commission's Staff Conference on December 20, 2021. The Public Staff recommended that the Commission issue an order recognizing the contiguous extension and approving the requested rates.

Based upon the verified Notification, and the entire record in this matter, the Commission makes the following

FINDINGS OF FACT

- 1. Aqua presently holds water franchises serving approximately 82,000 customers and sewer franchises serving approximately 20,000 customers throughout North Carolina. Aqua's record of service is satisfactory.
- 2. Aqua does not presently serve any water customers in The Manors at Waterstone Reserve. Aqua expects eventually to serve 38 water customers in The Manors at Waterstone Reserve. The service area is shown on plans filed with the Notification.

- 3. The North Carolina Department of Environmental Quality, Division of Water Resources, Public Water Supply Section, issued a plan approval letter for The Manors at Waterstone Reserve, part of Water System No. NC4092136. The plans are approved under serial number 20-00754, by letter dated November 6, 2020.
- 4. Aqua entered into a Water Utility System Agreement dated September 8, 2020 (Agreement), with Waterstone Partners, LLC (Developer), under which Developer is installing the water utility system. Aqua is purchasing the water system from Developer for \$700 per single-family residential equivalent (SFRE), payable quarterly basis on the number of SFREs connected during the previous quarter. Aqua is requesting a meter installation fee of \$70 for water service, to be paid one time by the builder or person first requesting service to a particular lot. Aqua is to pay the Developer \$1,200 per well towards costs associated with well testing.
- 5. Pursuant to the Commission's August 26, 2019 Order in Docket No. W-100, Sub 57, a utility is required to collect income tax on contributions in aid of construction (CIAC) from a contributor when contributions were contracted for on or after October 5, 2018. Notwithstanding the Commission's August 26, 2019 Order, in accordance with N.C. Gen. Stat. § 62-133.12B, beginning July 2, 2021, a "water or wastewater public utility is solely responsible for funding the income taxes on taxable contributions in aid of construction and customer advances for construction and shall record the income taxes the water or wastewater utility pays in accumulated deferred income taxes for accounting and rate-making purposes." Based on the foregoing, Aqua must collect income tax on taxable CIAC received prior to July 2, 2021, from the contributor. Income taxes on taxable CIAC received on or after July 2, 2021, must be handled in accordance with N.C.G.S. § 62-133.12B.
 - 6. Agua has filed all required exhibits with the Notification.
- 7. Aqua has the technical, managerial, and financial capacity to provide water utility service in this franchise location.
- 8. Aqua proposes to charge The Manors at Waterstone Reserve its uniform statewide water utility service rates approved in Docket No. W-218, Sub 526.
- 9. The Public Staff recommended that Aqua be required to post a \$10,000 bond for The Manors at Waterstone Reserve. Aqua currently has \$13,000,000 of bonds posted with the Commission. Of this amount, \$12,510,000 of bond surety is assigned to specific subdivisions, and \$490,000 of bond surety is unassigned.

CONCLUSIONS

Based on the foregoing and the recommendations of the Public Staff, the Commission concludes that \$10,000 of Aqua's unassigned bond surety should be assigned to the contiguous extension; that the contiguous extension by Aqua into The Manors at Waterstone Reserve should be recognized as meeting the Commission's criteria for the extension; that the meter installation fee for water utility service should be approved; and that the requested rates should be approved.

IT IS, THEREFORE, ORDERED as follows:

- 1. That \$10,000 of Aqua's unassigned bond surety is assigned to The Manors at Waterstone Reserve. The remaining unassigned bond surety shall be \$480,000;
- 2. That the contiguous extension of water utility service from Waterstone Reserve service area to The Manors at Waterstone Reserve in Wake County, North Carolina, is recognized as meeting the Commission's criteria for the extension pursuant to N.C.G.S. § 62-110(a), and Appendix A, attached hereto, constitutes Aqua's Certificate of Public Convenience and Necessity covering the contiguous extension;
- 3. That Aqua's existing Schedule of Rates approved by Commission Order issued on October 26, 2020, in Docket No. W-218, Sub 526, is approved for water utility service in The Manors at Waterstone Reserve; and
- 4. That a meter installation fee of \$70 for water utility service is approved for The Manors at Waterstone Reserve.

The Commission may consider additional or alternative rate design proposals which were not included or proposed in the original application and may order increases or decreases in the utility rate schedules which differ from those proposed by the Applicant. However, any rate structure considered will not generate more overall revenues than requested.

EFFECT OF RATES

The present water rates have been in effect since the Commission's Order issued on September 17, 2019 in Docket No. W-1250, Sub 7. The proposed rates would increase the average monthly bill for residential water utility service by \$3.85 (6%), from \$63.93 to \$67.78, based on 4,000 gallons of usage.
