Reference: Complaint of Rhett Taber v. Duke Energy Carolinas, LLC property

I request this complaint not be dismissed.

When this issue began, I sought help from my elected officials. Throughout this entire process, numerous people from Duke Power told Mr. Dan Girlie (919-856-3110) at the NC Speaker of the House's Office that someone from Duke Power would contact me and try to reach an agreement. This went on for many months. At one point, Mr. Girlie spoke to NCDOT Engineer Brian Birch and confirmed this.

I have been denied any due process because Duke Power told the Speaker's Office they would call me to discuss this issue, while at the same time, unknown to me, the other so-trustee of the property or any of my siblings, Duke Power proceeded with their plan to place the poles on our property. Neither I nor the other co-trustee was ever told of any hearing or condemnation process. I believed everything was put on hold and that Duke Power was going to reach out to me to reach an agreement. I was deceived into believing that Duke was proceeding in good faith and was going to work out an agreement while unknown to anyone they were proceeding with their plan. This conduct is disingenuous to say the least.

NCDOT had enough right of way to complete NCDOT's project without taking additional land. The taking was done to allow Duke Power a distance of 12 feet from the curb to the pole. At the onset, NCDOT engineer Brian Birch suggested putting the poles on the opposite side of the street, where Duke already had a right of way

and power poles. Duke Power refused, simply commenting that "they couldn't." Many months after they put the poles on our property they offered to move them to the exact spot they told Brian Birch they couldn't place them if I paid them \$100,000.

For clarification: regarding comment 3 by Robert Kaylor, the road widened was not Interstate 26. It was an acceleration lane on Highway 25.

I have previously sent and referenced an email exchange between me and NCDOT Bob Mabry. Initially our conversation was quite pleasant. He apologized and told me he would have the poles moved. Then he asked if I would accept just one pole moved. Then he "went silent", not accepting or returning my phone calls or emails. Ultimately he sent an email stating he would move the poles if I paid Duke Power \$100,000.

- 1. Complaint against Duke Power and NCDOT
- 2. I have communicated with Mr. Tommy Williamson. The informal complaint has not been successfully resolved.
- 3. My family owns a small piece of land in Naples, North Carolina (near Fletcher), close to Hendersonville in Henderson County. It has been in my family since before the American Revolution. This property has been the subject of numerous takings by Duke Power, NC DOT, and other utilities. In 2019 my family was contacted by NC DOT engineer Mr. Brian Birch (919) 707–2511;(828) 226–1777. Mr. Birch explained that Duke power wanted to run additional power lines and that would require yet another taking. My family protested this additional taking. We met Mr. Birch on site. He knows my family from previous takings of the same property. NC DOT engineer Birch had the simple solution to put the power line and two poles on the opposite side of the highway, where power lines already existed. We all thought this was a great solution. I might point out that my father (now deceased) was an engineer and three of my brothers are engineers. We all saw this could easily be done. Mr. Birch checked with his appropriate colleagues at NC DOT. NC DOT had no problems putting the poles on the opposite side of the road. Mr. Birch later said that Duke Power claimed it could not be done. He gave no reason. He simply said Duke Power said it could not be done. I contacted my state representative Mr. McGrady who directed me to Mr. Dan Gurley (919) 856-3111, Deputy Chief of Staff for the NC Speaker of the House. Mr. Gurley contacted Brian Birch and verified that NC DOT had no problems putting the line and poles on the opposite side of the highway and also

that Duke Power told him it could not be done. Mr. Gurley contacted Duke and they told him they would contact me and try to reach a solution. No one from Duke Power ever called. I called Mr. Gurley and told him I had not been contacted. He called Duke again and again was told they would contact me. Again Duke failed to contact me. This happened multiple times. For two years Mr. Gurley was told by Duke they would contact me. While Duke was representing to the office of the North Carolina Speaker of the House that they would contact me to reach a solution, Duke Power and NC DOT trespassed on our property and ran the disputed power lines. Neither Duke nor NC DOT have an easement nor have paid us for this trespass. They simply took our property without compensation while falsely representing to the Speaker's office they would contact me and find a solution. When I exposed what happened to Mr. Gurley he gave me the name and number of Mr. Bob Mabry (828) 674–0509 who works for Duke Power. Mr. Mabry gave me the name and number of Mr. Jason Wall (803) 818-7593.

My initial conversation with Jason Wall was lengthy and quite pleasant. He apologized for what happened and assured me he would correct the problem. He told me he was the engineer at Duke responsible and would get the poles moved. I asked if he had the authority to have the poles moved and he assured me he did. He also told me he had been with Duke Power a long time and became an engineer through the "school of hard knocks" and did not have a formal engineering degree. A short while later I received an email from Wall asking if I would be satisfied with moving one of the two poles. I told him I would not because that would still require my family losing the same amount of property (again). He understood and said he would be in touch within two weeks. Six weeks passed. He stopped accepting or returning phone calls or emails. I called Bob Mabry and told him that Jason Wall had gone silent. Finally I got an email, from Wall telling me they would move the two poles to the opposite side of the road if I paid Duke Power \$100,000. So if I paid Duke Power \$100,000, Duke would do exactly what they told NC DOT they could not do.

This trespass and taking without compensation is not only illegal, it is unprofessional and unethical. Most people would consider asking for \$100,000 to be extortion. We all want a safe and reliable power. There was a solution that Duke chose to ignore while telling Dan Gurley they would contact me.

- 4. Please contact NC DOT engineer Brian Birch (919) 707–2511; (828) 226-1777 and Mr. Dan Gurley (919) 856–3110 to verify what I've put in print and signed.
- 5. I want the two poles moved to the opposite side of the road as NC DOT engineer Brian Birch proposed. My family has suffered too many takings and Duke Power should not be allowed to get away with this unethical, unprofessional, illegal and bullying conduct.
