- 1. Review of Plant System Readiness Review:
  - Confirm that the required systems reviews were performed and validated during a Plant Manager Site Senior Team Challenge meeting.
- 2. Document that the heating systems in out-buildings are functioning properly.
- 3. Document that building doors or outside openings, which are required to protect sensitive equipment, are functioning properly.
- 4. Document that plant heat tracing controllers are installed and functioning properly.
- 5. Document that open modifications which may impacting winter reliability.
- 6. Document the following:
  - a. External piping required to be drained and capped is completed.
  - b. Traveling screens are properly weatherized and functional.
  - c. Leaks on outside components are repaired or protected from freezing.
- 7. Document site-specific issues/concerns for winter execution.
- 8. Historical Site cold weather related issues that could impact Winter Readiness. Include planned contingencies actions.
- Identify any anomalies / deficiencies in current Operational Decision Making (ODM), and any longterm trends which could challenge winter readiness and actions to mitigate.
- 10. Forced Outage Readiness Confirm readiness including Lessons Learned from prior forced outages have been implemented.
- 11. Winter Readiness items NOT completed are listed in site action register.
- 12. Review CAP data from at least the previous winter season, as a component of identifying potential equipment issues.
