NOW COMES AQUA NORTH CAROLINA, INC. ("Aqua" or "Company"), by and through the undersigned counsel, to make this filing in compliance with Ordering Paragraphs 26 and 27 of the Order Approving Partial Settlement Agreement and Stipulation, Deciding Contested Issues, Granting Partial Rate Increase, and Requiring Customer Notice ("2020 Rate Case Order") entered in this docket by the North Carolina Utilities Commission ("Commission") on October 26, 2020.

Aqua asserts the following in support of this filing, which is denominated a Notice:

1. On December 31, 2019, Aqua filed an Application with the Commission seeking authority to adjust and increase its rates for providing water and sewer utility service in all of its service areas in North Carolina. Within its Application, Aqua notified the Commission of its intent to implement its proposed

rates on a partial, temporary basis subject to refund, pursuant to G.S. 62-135, effective for service rendered on and after six months from January 30, 2020, or July 30, 2020.

- 2. On June 11, 2020, Aqua filed a motion requesting, among other things, approval of an undertaking to refund and approval of Notices to Customers.¹ On June 23, 2020, the Commission issued an Order denying use of a revenue deferral mechanism, approving Aqua's financial undertaking, and approving the Company's Notices to Customers, noting that the choice to exercise the remedy provided by G.S. 62-135 belongs to the Company and is not determined by the Commission. Upon review of Aqua's motion, the Commission found that the Company had satisfied the statutory requirements necessary to place new rates into effect on a partial, temporary basis. subject to refund with interest at a rate of 10% per annum, effective July 30, 2020.
- 3. On July 1, 2020, Aqua filed a motion seeking Commission approval of revised Notices to Customers. In its motion, Aqua sought to implement partial, temporary rates under bond at a lower level than it previously requested and which were authorized in the Commission's June 23, 2020 Order. Also, on July 1, 2020, Aqua filed its executed Undertaking to Refund.
- 4. On July 2, 2020, the Commission entered an *Order Approving*Revised Customer Notices and Accepting Financial Undertaking in this docket. By
 that Order, the Commission found that Aqua's request for approval of revised

¹ Specifically, Aqua notified the Commission that it intended to place temporary rates into effect pursuant to G.S. 62-135 in three of its five Rate Divisions; i.e., the Aqua Uniform Water Rate Division, the Aqua Uniform Sewer Rate Division, and the Company's Brookwood Water Rate Division.

Notices to Customers would result in lower partial, temporary rates than previously requested and that the Company had satisfied the statutory requirements necessary to place new rates into effect on a partial, temporary basis, subject to refund with interest at a rate of 10% per annum, effective July 30, 2020. Therefore, the Commission found good cause to approve the revised Notices to Customers attached to its Order as Appendices A and B and to accept Aqua's executed Undertaking to Refund filed on July 1, 2020, in this docket.

- 5. On October 26, 2020, the Commission entered its 2020 Rate Case Order in this docket. Ordering Paragraphs 26 and 27 of the 2020 Rate Case Order provided as follows:
 - 26. That Aqua NC shall refund all partial, temporary rates and charges in excess of the final rates and charges found to be appropriate by the Commission, if any, in the Aqua NC Water, Aqua NC Sewer, and Brookwood Water Rate Divisions with interest at 10% compounded annually.
 - 27. That Aqua NC shall file a refund plan for the excess partial, temporary rates and charges collected from the customers, if any, in the Aqua NC Water, Aqua NC Sewer, and Brookwood Water Rate Divisions within 30 days of the date of this Order and the Public Staff shall file a response to said refund plan no later than 60 days from the date of this Order.
- 6. In its proposed interim rates, Aqua adjusted and increased the Company's then-existing rates for the Aqua Uniform Water Rate Division to produce an increase in annual service revenues of \$1,867,058; an increase in annual service revenues for the Aqua Uniform Sewer Rate Division of \$788,884; and an increase in annual service revenues for the Brookwood Water Rate Division of \$627,167.

- 7. The Commission, in the 2020 Rate Case Order, approved the following increases in the Company's annual service revenues by Rate Division: Aqua Uniform Water: \$1,986,987; Aqua Uniform Sewer: \$818,429; and Brookwood Water: \$656,719.²
- 8. Thus, the annual rate increases allowed by the Commission for each of Aqua's three Rate Divisions in the 2020 Rate Case Order which were subject to the interim rate increases were more than what the Company imposed and collected in its interim rates. For that reason, Aqua maintains that no refunds to customers are required.
- 9. Exhibit 1 attached to this Notice documents Aqua's position that no refunds of the temporary, interim rates collected by the Company pursuant to G.S. 62-135 between July 30, 2020 (the date Aqua put interim rates into effect), and October 26, 2020 (the effective date of the Commission's 2020 Rate Case Order) are required.

WHEREUPON, Aqua requests that the Commission accept this filing in full compliance with Ordering Paragraphs 26 and 27 of the 2020 Rate Case Order and enter a further Order ruling that the Company has no refund obligation under the provisions of G.S. 62-135 with respect to the collection of temporary, interim rates.
