BY THE COMMISSION: On March 31, 2015, Carolina Water Service, Inc. of North Carolina (CWSNC or Applicant), filed an application with the Commission seeking authority to increase its rates for providing water and sewer utility service in all of its service areas in North Carolina. The Applicant serves approximately 18,481 water customers and 11,985 sewer customers, including 909 customers in Corolla Light and Monteray Shores (OBX), 630 sewer-only customers in Nags Head, and 356 water-only customers in Linville Ridge Subdivision. The present rates for water and sewer service in all of the Applicant's service areas have been in effect since July 1, 2014, pursuant to the Commission's Order of June 27, 2014, in Docket Nos. M-100, Sub 138, and W-354, Sub 342, and the Commission's Order of July 8, 2014, in Docket No. W-354, Sub 336.

On April 30, 2015, the Commission issued an Order establishing a general rate case and suspending the rates.

On May 6, 2015, CWSNC filed Revised Appendix A-1 to clarify, revise, amend, and properly reflect the new proposed rates being requested by the Company in this case for all of its water and sewer service areas in North Carolina, excluding Corolla Light, Monteray Shores, and Nags Head.

CWSNC is proposing a separate usage charge, based on the supplier's rates, for its purchased water and purchased sewer systems, and a collection fee for its purchased sewer systems. CWSNC is also proposing its uniform rates for water utility service in Linville Ridge Subdivision.

CWSNC is requesting to increase the new sewer customer charge from \$20.70 to \$22.00 and return check charge from \$14.11 to \$25.00 for Nags Head; and increase the meter testing fee from \$19.20 to \$20.00, new water customer charge from \$25.92 to \$27.00, reconnection charge for commercial customers from \$25.92 to \$27.00, and return check charge from \$24.00 to \$25.00 for Linville Ridge Subdivision.

The proposed new rates will increase the average monthly sewer bill for 5/8" residential metered customers by approximately 27.7%, from \$81.17 to \$103.63, based on an average usage of 4,347 gallons.

The proposed new rates will increase the average monthly sewer bill for 5/8" residential metered customers by approximately 21.2%, from \$62.81 to \$76.11.

On May 13, 2015, the Applicant filed a letter stating that given the timing of its general rate case filing, the evidentiary hearing would normally have been set for a date near the end of August or early September, 2015; however, at CWSNC's request, the evidentiary hearing date is being extended by approximately 30 days in order to allow the Applicant additional time necessary to complete a major project, which is essential for inclusion in this rate case. CWSNC also stated that because of its request for a later evidentiary hearing date, it agrees to waive, for 30 days or until November 29, 2015, its right under GS 62-135 to put the suspended rates into effect, temporarily and under bond.

The Public Staff recommended that the Applicant's request for waiver by 30 days of its right under GS 62-135 to put the suspended rates into effect, temporarily and under bond be granted, the matter be scheduled for hearings and that customers be notified.

The Commission is of the opinion that the application should be scheduled for hearings, customers should be notified, and that the Applicant's request to waive by 30 days or until November 29, 2015, its right under GS 62-135 to put the suspended rates into effect, temporarily and under bond should be granted.

IT IS, THEREFORE, ORDERED as follows:

1. That the application is scheduled for evidentiary hearing as follows:

3. That the hearings scheduled for June 23 and 24 and July 7, 8, 22, and 23 shall be for the purpose of receiving customer testimony. The hearing scheduled for October 5 and 6, 2015, shall be for the purpose of receiving testimony of the Applicant, the Public Staff, and any other parties of record. Customers who are unable to attend any of the first six hearings may also be heard on Monday, October 5, 2015.

4. That the Applicant is required to file all testimony on which it will rely at hearing on or before August 21, 2015, and shall prefile any rebuttal testimony no later than September 22, 2015. However, this prefiling is without prejudice to the right of the Applicant to add, supplement, or amend rebuttal testimony in light of developments during the hearing. The Public Staff shall prefile testimony on September 15, 2015.

5. That the Applicant is required to notify the Public Staff of all updates and supporting data by August 17, 2015. This requirement shall not apply to events that are neither foreseeable nor within the Applicant's control. This requirement shall not prevent the Applicant from providing evidence showing changes in costs, including plant in service additions, pursuant to G.S. 62-133(c).

6. That an officer or representative of the Applicant is required to appear in person before the Commission at the time and place of the evidentiary hearing to testify concerning any of the information contained in the application. If the Applicant desires to cross-examine any witnesses at the hearing, the Applicant shall be represented by legal counsel at this hearing.



That the Notice to Customers, attached hereto as Appendixes A-1 through A-4, be mailed with sufficient postage or hand delivered by the Applicant to all customers affected by the proposed new rates no later than 15 days after the date of this Order; and that the Applicant submit to the Commission the attached Certificate of Service properly signed and notarized not later than 25 days after the date of this Order.

8. That the six-month period under which temporary rates may be put into effect under bond shall be extended by 30 days or until November 29, 2015.

Written statements are not evidence unless those persons submitting the statements appear at the public hearing and testify concerning the information contained in their written statements.


Persons desiring to present testimony concerning their opinion on this application, or on any service problems they may be experiencing, may appear at the public hearing and give such testimony.






