- 6 its sales by .75 per dekatherm, and its transportation rates by 1.43 cents
- 7 per dekatherm, effective for service rendered July 1st, 2021. The increase
- B is a result of the change of Piedmont's benchmark quantity gas cost from
- 9 \$2.50 per dekatherm to \$3.25 per dekatherm, as well as the change in Company
- 10 use in unaccounted for gas as described in Piedmont's Appendix A.
- 11 The Public Staff has reviewed the Application and proposed rates,
- 12 and recommends approval as filed.
- 13 COMMISSIONER BROWN-BLAND: Move approval of the recommendation.
