NOW COME Duke Energy Carolinas, LLC ("DEC") and Duke Energy Progress, LLC ("DEP") (together referred to as the "Companies") and respectfully move the North Carolina Utilities Commission (Commission) to extend the time for the Companies to file their report upon the data and information that will be provided in future reports for the Customer Assistance Program ("CAP"). In support of this motion, the Companies respectfully show the following:

On August 18, 2023, the Commission issued its Order Accepting Stipulations,
 Granting Partial Rate Increase, and Requiring Public Notice, in Docket No. E 2, Sub 1300 ("the Order") that directed DEP to convene a stakeholder

- engagement process to (i) consider data and reporting issues that may be necessary for the CAP, (ii) consider metrics and inputs used to assess the CAP pilot, and (iii) update the Commission on the stakeholder process.
- 2. The Order also directed the stakeholder group to agree upon the data and information that will be provided in an annual report that will be filed each year that the CAP is effective, no later than six months after the issuance of the Order. The Commission directed seven specific types of information to be included in the annual report.
- 3. DEP convened the Affordability Stakeholder Group ("ASG") in compliance with the Order on November 9, 2023.
- 4. The Companies in consultation with the members of the ASG are continuing to evaluate the data and information that will be provided in the annual report.
- 5. The Companies are also continuing to evaluate any necessary waivers to provide zip code related data as required in the seven Commission-required sets of data.
- 6. The Companies need additional time to evaluate the data and information that will be provided in the report and the necessary waivers, as well as additional time to discuss these issues with members of the ASG, including the Public Staff.
- 7. The Companies therefore respectfully request and move that the deadline to file their report upon the data and information that will be provided in the reports for the Customer Assistance Program ("CAP") be extended thirty calendar days from February 19, 2024, to March 18, 2024.

WHEREFORE, the Companies respectfully request and move that the deadline to file their report upon the data and information that will be provided in the reports for the Customer Assistance Program ("CAP") be extended thirty calendar days from February 19, 2024, to March 18, 2024.
