On June 19, 2018, the Commission issued its *Order Approving Appendix F and Establishing Pilot Program* in Docket No. G-9, Sub 698. In that Order, the Commission required revisions to Piedmont Natural Gas Company, Inc.'s ("Piedmont") Alternative Gas Standard, Appendix F to the North Carolina Service Regulations. Ordering Paragraph No. 8 of the Commission's Order requires monthly reports documenting daily quantity, heat content, and WOBBE numbers associated with Alternative Gas delivered to Piedmont by various Alternative Gas suppliers. The Commission subsequently issued its *Order Accepting Compliance Filing in Part and Requiring Revisions*, on October 30, 2018, in which it ordered Piedmont to include in this monthly report specific gravity associated with Alternative Gas delivered to Piedmont to Piedmont, calculated to three decimal places.

This electronic filing constitutes Piedmont's monthly report for the month ending January 2024.

Because this report discloses information that is confidential in nature regarding the nature, quality, and quantity of gas produced by an Alternative Gas supplier, Piedmont hereby designates its report as the confidential and proprietary trade secret of Piedmont pursuant to N.C. Gen. Stat. § 132-1.2, and requests that the Commission treat this report in a manner consistent with this designation.
