BY THE PRESIDING COMMISSIONERS: On July 20, 2023, the Public Staff — North Carolina Utilities Commission (Public Staff) filed a motion requesting the Commission to extend the deadline for parties to file proposed orders and briefs in Docket Nos. E-7, Subs 1281 and 1282.

In accordance with the ruling of Presiding Commissioner Kimberly W. Duffley in open hearing on May 30, 2023, proposed orders and briefs need to be filed no later than July 21, 2023, for Duke Energy Carolinas, LLC's (DEC) Competitive Procurement of Renewable Energy (CPRE) Program Cost Recovery Rider and Compliance Report (Docket No. E-7, Sub 1281).

Also, in accordance with the ruling of Presiding Commissioner Karen Kemerait in open hearing on May 31, 2023, proposed orders and briefs need to be filed no later than July 21, 2023, for DEC's fuel and fuel-related charge adjustments (Docket No. E-7, Sub 1282).

In support of its motion, the Public Staff states that because of the press of other business, particularly the intervener testimony deadline of June 19, 2023, in the DEC rate case, the Public Staff requires additional time to draft and file its proposed order and to

brief the requested issue. Particularly, the Public Staff states that a one business day extension, to Monday, July 24, 2023, would provide the Public Staff and other parties with sufficient time to file their proposed orders and briefs. The Public Staff further states that it has contacted counsel for DEC and the intervening parties in both dockets concerned and is authorized to represent that no party objects to this motion.

In light of the foregoing, the Presiding Commissioners are of the opinion that good cause exists to extend the deadline for the parties to file proposed orders and briefs to July 24, 2023, for the above-captioned proceedings.

IT IS, THEREFORE, SO ORDERED.
