NOTICE IS HEREBY GIVEN that on May 7, 2018, Apex Solar, LLC (Applicant), filed an application seeking a certificate of public convenience and necessity pursuant to G.S. 62-110.1(a) for construction of a 30-MW solar generating facility to be located on the west side of Plainsview Church Road, approximately 0.5 miles west of the intersection with East Stage Coach Trail, Lawndale, Cleveland County, North Carolina. The Applicant plans to sell the electricity to Duke Energy Carolinas, LLC.

If no complaint is received within the time specified above and if the Commission does not order a hearing upon its own initiative, the Commission will enter an order awarding the certificate sought by the Applicant.
