Currituck Water and Sewer Company, LLC (CWS), through counsel, and the Public Staff - North Carolina Utilities Commission (Public Staff), through its Executive Director, Christopher J. Ayers (collectively, the Parties) request that the North Carolina Utilities Commission (Commission) issue an order cancelling the public hearing scheduled for May 9, 2024. In support of this motion, the Parties show the following:

1. This docket arises from CWS's application for a certificate of public convenience and necessity to provide water and wastewater service to the Carolina Village Subdivision in Currituck County submitted to the Commission on August 16, 2023.
2. On February 14, 2024, the Commission issued its Order Scheduling Hearing, Establishing Discovery Guidelines and Requiring Customer Notice (Scheduling Order) setting this matter for a public witness hearing on Monday, May 20, 2024.
3. On February 16, 2024, CWS filed a motion asking that the public witness hearing be rescheduled.
4. On February 29, 2024, the Commission issued its Order Rescheduling Public Witness Hearing and Revising Date for Reports and Customer Notice (Rescheduling Order) rescheduling the public witness hearing to May 9, 2024. Per ordering paragraph 2 of the Rescheduling Order, "the Commission may cancel the public

witness hearing if no significant protests are received on or before Thursday, May 2, 2024.”

5. No consumer complaints have been filed in this docket or received by the Public Staff.

WHEREFORE, the Parties move that the Commission cancel the public witness hearing scheduled for May 9, 2024.
