
This filing is an amendment to the application for a Certificate of Public Convenience and Necessity ("CPCN") in the above-referenced docket pursuant to Rule R8-64(d)(3). The original CPCN application was filed on February 27, 2015.

The CPCN application was inadvertently filed with maps that were missing one parcel of land required for the facility to be constructed to the proposed capacity of 80-MW<sub>AC</sub>. Aulander Holloman Solar, LLC has entered into a site control agreement with landowner FIATP SSF Timber, LLC for the additional property for the facility.

Enclosed and marked as Aulander Holloman Solar Amendment: Exhibit 1 is an amended location map which reflects the project boundary with the additional land and landowner identified. Also enclosed and marked as Aulander Holloman Solar Amendment: Exhibit 2 is an amended proposed layout which reflects the facility footprint with the additional land. The general location description for the facility remains the same as per the original application.

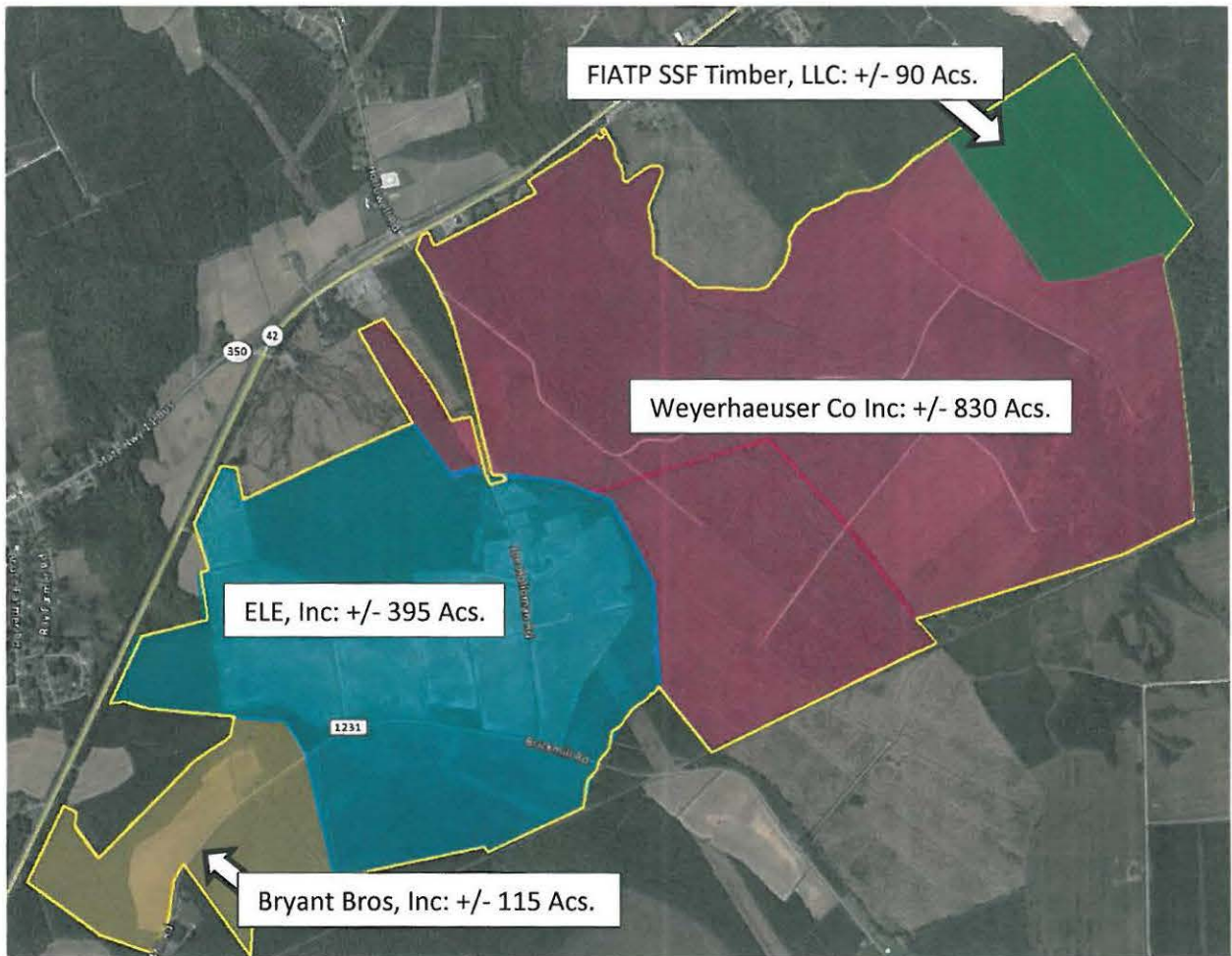

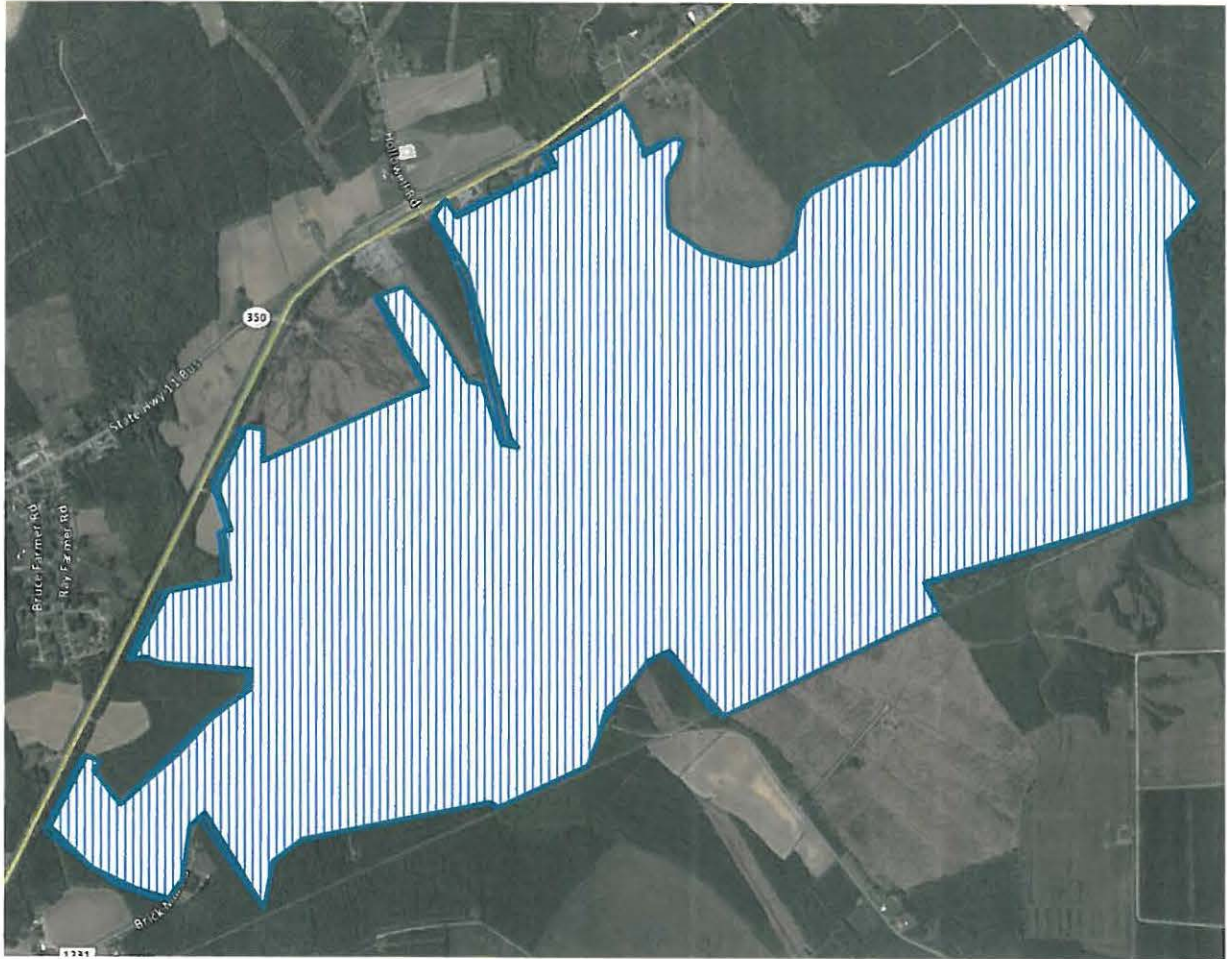
## Aulander Holloman Solar Amendment: Exhibit 1
