BY THE PRESIDING COMMISSIONER: On October 1, 2020, Duke Energy Progress, LLC (DEP), filed with the Commission a Motion for Leave to Designate Late-Filed Potential Redirect Exhibits in the above dockets. In summary, and in response to the Public Staff’s Motion for Leave to Designate Late-Filed Potential Cross Exhibits approved by the Commission on September 29, 2020, DEP seeks leave to designate as potential redirect exhibits to the Public Staff’s potential Cross Examination Exhibits 140, 141, and 142, the following:

DEP Exhibit 76: Wolfe Research Report on Duke Energy titled “As With College Football Fans this Week, Looking to 2021,” dated August 11, 2020

DEP Exhibit 77: Evercore ISI Report on Duke Energy Corp. titled “Coal Ash Recovery in Focus as DUK Rebases Outlook,” dated August 10, 2020

DEP attached the documents to its motion. DEP also represented that it conferred with the Public Staff on September 28, 2020, and that, at the time of filing, “Public Staff has not indicated that it has any objection to the Company’s request...”

Based on these representations and the records in these dockets, the Presiding Commissioner finds good cause to allow the motion. DEP may designate as DEP Potential Redirect Exhibits 76 and 77 the documents it attached to its motion.
