## RED BIRD FILING PURSUANT TO ORDER SCHEDULING HEARING

The Order Scheduling Hearing, Establishing Discovery Guidelines, And Requiring Customer Notice issued in these dockets on January 5, 2022 ("Scheduling Order"), directed Red Bird Utility Operating Company, LLC ("Red Bird") to "consult with all other parties and file, no later than Monday, March 21, 2022, a list of witnesses to be called at the hearing, the order of witnesses, and the estimated time for cross-examination." Cancerning Treating, Approving Supulation, Approving Bond, And Approving Transier

And Rates ("Joint Motion") in these dockets. Those parties also filed a Joint Proposed

Order granting the relief requested in the Joint Motion.

The Settlement Agreement and Stipulation entered into by the Public Staff and

has questions for these witnesses, there will be no cross examination of either witness.
