On August 17, 2018, OptimaTH, LLC ("OptimaTH") filed in this docket a form of Receipt Interconnect Agreement ("Agreement") negotiated between OptimaTH and Piedmont Natural Gas Company, Inc. ("Piedmont"). This form of Receipt Interconnect Agreement relates to a prospective new swine gas production project to be located in Tarheel, North Carolina and connected to Piedmont's system. This is the same project OptimaTH has previously proposed to include in the Alternative Gas Pilot Program for Piedmont established by the Commission's June 19, 2018 Order Approving Appendix F and Establishing Pilot Program in Docket No. G-9, Sub 698. By this Filing Piedmont wishes to articulate its position on OptimaTH's August 17, 2018 filing in this docket so the record before the Commission is clear.

Piedmont acknowledges that the form of Receipt Interconnect Agreement filed by OptimaTH in this docket has been negotiated with Piedmont and sets forth terms pursuant to which Piedmont is willing to interconnect with OptimaTH's proposed Tarheel project facilities and receive Alternative Gas from those facilities.

In the event the Commission approves OptimaTH's request to include the Tarheel project in the Piedmont Pilot Program, which Piedmont does not oppose but otherwise takes no position on, Piedmont would respectfully support and seek Commission approval of the Receipt Interconnect Agreement and authorization to act in accordance with its terms.
