BY THE COMMISSION: On June 8, 2022, in the above-captioned docket, the Commission issued an Order Granting Application for a Certificate of Exemption (Order) authorizing Supreme Movers, LLC, to conduct intrastate household goods moves for compensation in the state of North Carolina. Ordering Paragraph No. 5 of the Order states, “[t]hat the Applicant shall attend an online Maximum Rate Tariff (MRT) Seminar no later than (3) months from the date of this Order”.

The Public Staff – North Carolina Utilities, Transportation Division, has since advised the Commission that Supreme Movers, LLC, and its representatives have failed to attend the Commission-required MRT training seminar within the three-month period following the issuance of Supreme Movers, LLC’s certificate of exemption.

The Commission’s official file in this docket shows that on January 12, 2023, Nicholas Jeffries, Director, Transportation Utilities Regulation, North Carolina Utilities Commission, sent by certified mail, a Cancellation Notice for Certificate of Exemption Number C-3015 for Failure to Attend Mandatory Maximum Rate Tariff (MRT) Seminar by the mandated three-month time frame. To date, Supreme Movers, LLC, has not contacted the Commission, nor attended any MRT training seminars, and has therefore failed to comply with the Commission’s June 8, 2022 Order.

Upon consideration thereof, the Commission concludes that Supreme Movers, LLC, must attend the next online MRT training seminar scheduled for February 21, 2023. If Supreme Movers, LLC, does not attend this online MRT training seminar, its certificate of exemption shall be suspended, and it will be ordered to appear before the Commission by separate order of the Commission to show cause why its certificate of exemption should not be revoked for failure to comply with the Commission’s orders.

IT IS, THEREFORE, ORDERED as follows:

1. That Certificate of Exemption No. C-3015 issued to Supreme Movers, LLC, shall be suspended as of February 22, 2023, and any further operation of its vehicles, leased or owned, upon the public highways of this State for the transportation of household goods on and after said date is illegal and is hereby, prohibited;


2. That Supreme Movers, LLC's attendance at the February 21, 2023 MRT training seminar will cause the suspension ordered herein to become null and void and of no further force and effect; and

3. That this Order shall be served on Supreme Moving, LLC, by United States certified mail, return receipt requested.
