NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission (Public Staff), by and through its Executive Director, Christopher J. Ayers, and respectfully moves the North Carolina Utilities Commission (Commission) for an extension of 14 days for the filing of proposed orders and/or briefs as set out in the Commission’s Notice of Due Date for Proposed Orders and/or Briefs filed in this proceeding on July 14, 2022. In support of this motion, the Public Staff respectfully shows the Commission the following:

1. On July 5, 2022, on behalf of Cardinal Pipeline Company, LLC (Cardinal), Piedmont Natural Gas Company, Inc., and the Public Staff – North Carolina Utilities Commission (“Public Staff”) (collectively the “Stipulating Parties”),

Cardinal filed a Stipulation in these dockets resolving the issues before the Commission.

2. The Public Staff and Cardinal have been working diligently on the late-filed exhibit regarding depreciation along with a joint proposed order but need additional time to finalize them.

3. In light of the foregoing, the Public Staff respectfully requests that the Commission extend the due date for the filing of a joint proposed order from August 15, 2022, to August 29, 2022.

4. Counsel for the Public Staff conferred with Cardinal's counsel and the other parties and is authorized to represent that no party objects to the Public Staff's motion.

WHEREFORE, for the reasons set forth above, the Public Staff respectfully requests that the Commission issue an order extending the time for filing the joint proposed order to and including August 29, 2022.
