Dear Ms. Dunston:

On August 4, 2023, the Commission issued an Order in the above-referenced docket approving Duke Energy Carolinas, LLC's ("DEC") and Duke Energy Progress, LLC's ("DEP" and, together with DEC, the "Companies") Net Excess Energy Credit ("NEEC") that was originally filed as Exhibit 2 to the Companies' March 31, 2022 Reply Comments in the above-referenced docket. The Order additionally instructed the Companies to file their respective NEECs to become effective October 1, 2023.

This letter confirms that the Companies have filed the as-approved NEEC as part of their Net Energy Metering Compliance Tariffs filed with the Commission on May 25, 2023 in Docket No. E-100, Sub 180 (the "NEM Compliance Filing"). Although the Commission had not yet approved the NEEC at the time the Companies made their NEM Compliance Filing, the Compliance Tariffs included the now-approved NEEC with an effective date of October 1, 2023 as directed by the Commission. Since the Commission's Order did not direct any changes to the NEEC, the Companies do not need to update their NEM Compliance Filing now on file with the Commission, and the rates therein will take effect as ordered on October 1, 2023.

As directed in Commission's August 4, 2023 Order, the Companies will calculate and file an updated NEEC as part of their November 1, 2023 filings in Docket No. E-100, Sub 194.
