In compliance with Decretal Paragraphs 7 and 8 of the *Order Scheduling Hearing, Establishing Intervention and Testimony Due Dates and Discovery Guidelines, and Requiring Notice*, entered by the North Carolina Utilities Commission ("Commission") in Docket No. W-354, Sub 400 on September 2, 2022, Carolina Water Service, Inc. of North Carolina ("CWSNC" or "Company") hereby provides to the Public Staff and files with the Commission all updated information with supporting data, along with updated schedules, which the Company proposes to use to supplement its rate case application and request for rate relief in this docket.

As stated by the Commission in its scheduling order at Ordering Paragraph 7, page 5, this filing requirement:

...shall not apply to events that are neither foreseeable nor within the Company's control. This requirement shall not prevent CWSNC from providing evidence showing changes in costs, revenues, or plant in service additions pursuant to N.C. Gen.
