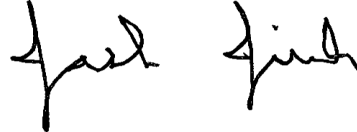

Pursuant to North Carolina General Statutes (“N.C. Gen. Stat.”) § 84-4.1 and Rule R1-22 of the North Carolina Utilities Commission (the “Commission”) Rules of Practice and Procedure, Ladawn S. Toon of Duke Energy Corporation respectfully requests the Commission to enter an order permitting her to practice *pro hac vice* before the Commission on behalf of Duke Energy Carolinas, LLC (“DEC” or the “Company”) in the above-captioned matter. In support of this motion, Ms. Toon alleges and shows the following.

1. The above-captioned matter is a regulatory proceeding before the Commission, governed by North Carolina public utility law.
2. DEC is a limited liability company, duly organized and existing under the laws of the State of North Carolina, and is a public utility under the laws of North Carolina with operations subject to the jurisdiction of this Commission.

3. Ms. Toon is an attorney in good standing, licensed to practice law in the State of Massachusetts, and she will appear on behalf of the Company in the above-captioned proceeding.

5. Ms. Toon will continue to represent the Company in the above-captioned proceeding until the final determination thereof, unless permitted to withdraw sooner by order of the Commission.

Ms. Toon has agreed to be subject to the orders and is amenable to the disciplinary action and civil jurisdiction of the General Court of Justice and the North Carolina State Bar in all respects as if she were a regularly admitted and licensed member of the Bar of North Carolina in good standing.

7. The Bar of Massachusetts, in which Ms. Toon is regularly admitted to practice, grants permission to members of the Bar of North Carolina in good standing to practice *pro hac vice* under circumstances similar to those authorized by N.C. Gen. Stat. § 84-4.1.

8. Ms. Toon, who is Associate General Counsel in Duke Energy's Raleigh, North Carolina office, is associated for purposes of appearing before the Commission with Jack E. Jirak, Deputy General Counsel at Duke Energy Corporation and a resident of this State who is duly and legally permitted to practice in the General Court of Justice of North

Carolina, upon whom service may be had in all matters connected with the legal proceedings, or any disciplinary matter, with the same effect as if personally made on Ms. Toon.


9. Ms. Toon has not been disciplined by any court or lawyer regulatory organization, nor has she had *pro hac vice* privileges revoked.



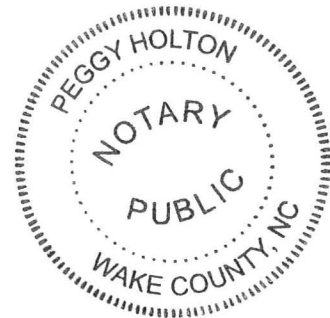


