NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission, by and through its Executive Director, Christopher J. Ayers, and pursuant to the Commission's Order Establishing Docket to Consider Impacts of 2017 Federal Tax Cuts and Jobs Act on Contribution in Aid of Construction and Requesting Initial and Reply Comments issued October 5, 2018 ("Order"), respectfully requests the Commission to extend the time for filing its recommendation in the above-captioned dockets to and including November 14, 2018. In support of this motion, the Public Staff shows as follows:

In the Order, the Commission addressed the impacts of the Federal
 Tax Cuts and Jobs Act (the Act).

- 2. In Ordering Paragraph 4 of the Order, the Commission directed DENC, among other companies, to file proposals in company-specific dockets to adjust their rates to reflect the reduction in the federal corporate income tax rate for taxable years beginning after December 31, 2017, as outlined in the Act.
- 3. In Ordering Paragraph 11 of the Order, the Commission also directed the Public Staff to work with DENC to determine the impact, if any, to DENC's State Tax Rider EDIT due to the Act, and to file a recommendation on how the Commission should address the decrease in the federal corporate income tax rate on DENC's State Tax Rider EDIT by no later than Friday, November 2, 2018.
- 4. On October 26, 2018, DENC filed a compliance filing to comply with Ordering Paragraph 4 of the Order. In that filing, DENC also included its proposal to address the Company's State Rider EDIT.
- 5. The Public Staff and DENC have been discussing DENC's proposal; however, additional time is needed to determine the impact to DENC's State Tax Rider EDIT due to the Act and for the Public Staff to present its recommendation to reflect the impact of the Act on DENC's State Tax Rider EDIT.
- 6. Because of the ongoing discussions with DENC, the Public Staff requests an extension, to November 14, 2018, for the Public Staff to file its recommendation on how to address the impact of the Act on DENC's State Tax Rider EDIT.
  - 7. DENC has no objection to this request for extension of time.

THEREFORE, the Public Staff moves:

That the Commission grant the Public Staff an extension of time until November 14, 2018, in which to file its recommendations in these dockets.
