NOW COMES the Public Staff of the North Carolina Utilities Commission (Public Staff), by and through its Executive Director, Christopher J. Ayers, and respectfully moves the North Carolina Utilities Commission (Commission) to extend the time for filing comments, interventions, and protests related to Duke Energy Progress, LLC's (DEP) Proposed Income Qualified Residential Load Control Program (EnergyWise) and Duke Energy Carolinas, LLC's (DEC and, together with DEP, Duke Energy or the Companies) Proposed Income Qualified Residential Load Control Program (Power Manager). In support of this motion, the Public Staff respectfully shows the Commission the following:

1. On September 11, 2023, Duke Energy filed in the above-captioned dockets its proposed EnergyWise and Power Manager programs (Proposed Programs) pursuant to Commission Rule R8-68.

- 2. Pursuant to Commission Rule R8-68(d)(2), the deadline for parties to file comments, interventions, and protests related to the Proposed Programs is October 11, 2023.
- 3. Due to the press of other business, the Public Staff requires additional time to conduct discovery and draft comments. A 30-calendar-day extension would provide the Public Staff and other parties with sufficient time to file comments, interventions, or protests.
- 4. The Public Staff therefore respectfully requests and moves that the deadline to file comments, interventions, or protests on the Proposed Programs be extended 30 calendar days, from October 11, 2023, to November 10, 2023.
- 5. The Public Staff has contacted counsel for DEC and the intervening parties. Although not all parties to these dockets have responded, DEC, the Attorney General's Office, Carolina Utility Customers Association, Inc., North Carolina Sustainable Energy Association, National Resources Defense Council, Southern Alliance of Clean Energy, Solar Energy Industries Association, and Sierra Club do not object to this motion.

WHEREFORE, the Public Staff respectfully requests and moves that the deadline for to file comments, interventions, or protests on the Proposed Programs be extended 30 calendar days, from October 11, 2023, to November 10, 2023.
