In the Matter of Application by Aqua North Carolina, Inc., 202 MacKenan Court, Cary, North Carolina 27511, for Authority to Amend Its Tariff to Increase Rates for Water Utility Service for the Increased Cost of Purchased Water from Johnston County Department of Public Utilities in 55 Subdivisions in Johnston County, North Carolina

ORDER APPROVING TARIFF REVISION AND REQUIRING CUSTOMER NOTICE

BY THE COMMISSION: On August 11, 2023, Aqua North Carolina, Inc. (Aqua or Company) filed a verified petition with the Commission, pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to its metered water customers in 55 subdivisions in Johnston County an increase in the cost of purchasing water service from the Johnston County Department of Public Utilities (County).<sup>1</sup> North Carolina Gen. Stat. § 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

Aqua stated that, effective September 1, 2023, the County will increase its usage rate charged to Aqua by \$0.20 per 1,000 gallons, from \$3.20 to \$3.40 per 1,000 gallons.

Aqua's current water usage rate related to its bulk purchased water service from the County became effective on September 1, 2022, upon issuance of the Commission's Order Approving Tariff Revision and Requiring Customer Notice in Docket No. W-218, Sub 580. After taking into account the effect of the County's base charge and 0.1475% regulatory fee, Aqua requested authority to increase its water usage rate from \$3.21 to \$3.42 per 1,000 gallons to reflect the increase in the cost of purchasing water service from the County. The current monthly base facility charge for a <1" meter is \$21.10 pursuant to the Commission's Order Approving Motion on Wastewater Rate Design and Approving Schedules of Rates, Schedules of Connection Fees, and Customer Notices issued in Docket No. W-218, Sub 573 on July 31, 2023.

In reviewing the petition, the Public Staff – North Carolina Utilities Commission (Public Staff) determined that the \$0.01 gross-up attributable to the 0.1475% regulatory fee should be rounded to the full penny to avoid that cost being allocated to other Aqua

customers (i.e., ANC Water customers). Therefore, the Public Staff recommends and Aqua has agreed to a water usage rate of \$3.41 per 1,000 gallons to reflect the increase in the cost of purchasing water service from the County, which does not include the allocation of the County's base charge in the usage charge.

Under the Public Staff's recommended water usage rate, the average residential customer's monthly water bill will increase by \$1.00, from \$37.15 to \$38.15 based on 5,000 gallons of usage.

The Public Staff presented this matter at the Commission's Staff Conference on September 18, 2023. The Public Staff stated that it had reviewed the County's rates and the Company's request and recommended that the Commission approve the tariff revision at the Public Staff's proposed rates for service rendered on and after the date of this order and require customer notice.

Based upon the foregoing, the Commission finds that Aqua should be allowed to pass through the costs associated with the increased purchased water expense as recommended by the Public Staff.

IT IS, THEREFORE, ORDERED as follows:

1. That Aqua North Carolina, Inc. is granted a revision to Appendix A-2 of its tariff for water utility service in 55 subdivisions in Johnston County in which it purchases and resells water from the Johnston County Department of Public Utilities, as set forth herein;

2. That the revised Appendix A-2 attached hereto is approved and deemed filed with the Commission pursuant to N.C.G.S. § 62-138. This Schedule of Rates shall become effective for service rendered on and after the date of this Order; and

3. That the Notice to Customers, attached hereto as Appendix B, shall be mailed with sufficient postage or hand delivered by Aqua to all its affected customers in the 55 subdivisions contemporaneously with the next billing of customers, and that Aqua shall submit to the Commission the attached Certificate of Service, properly signed and notarized, no later than ten days after the date of the next billing.

The monthly base facility charge for a <1" meter is 21.10 pursuant to Commission's order issued in Docket No. W-218, Sub 573 on July 31, 2023.

The new water usage rate will increase the average residential monthly water bill by \$1.00, from \$37.15 to \$38.15 based on 5,000 gallons of usage.

ORDER APPROVING TARIFF REVISION AND REQUIRING CUSTOMER NOTICE

BY THE COMMISSION: On June 23, 2023, Aqua North Carolina, Inc. (Aqua or Company) filed a verified request with the North Carolina Utilities Commission (Commission) pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to its metered water customers in the Chapel Ridge, Laurel Ridge, and The Parks at Meadowview service areas in Chatham County an increase in the cost of purchasing bulk water service from the Town of Pittsboro (Pittsboro). Section 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

On August 21, 2023, Aqua notified the Commission during its Regular Staff Conference that, due to the recent merger of Pittsboro's water system with the Town of Sanford's water system, Pittsboro had reduced its bulk water rate effective August 1, 2023. Aqua withdrew its original request for a rate increase and stated that it would file an amended request reflecting the decrease in the Pittsboro bulk water rate.

On August 29, 2023, Aqua filed an amended verified request for authority to amend its tariff for the purpose of passing along to its metered water customers in the Chapel Ridge, Laurel Ridge, and The Parks at Meadowview service areas a decrease in the cost of purchasing bulk water service from Pittsboro. Aqua stated that, effective August 1, 2023, Pittsboro decreased its bulk water usage rate above the contract minimum of 500,000 gallons per month by \$0.62 per 1,000 gallons, from \$23.69 per 1,000 gallons to \$23.07 per 1,000 gallons.

Aqua's current water usage rate related to its bulk purchased water service from Pittsboro became effective on July 27, 2022, upon issuance of the Commission's Order Approving Tariff Revision and Requiring Customer Notice in Docket No. W-218, Sub 577. After taking into account the effect of Pittsboro's minimum charge and the 0.1475% regulatory fee, Aqua requested authority to decrease its water usage rate from \$23.72 to \$23.10 per 1,000 gallons to reflect the decrease in the cost of purchasing bulk water service from Pittsboro. The current monthly base facility charge for a <1" meter is \$21.10

pursuant to the Commission's Order Approving Motion on Wastewater Rate Design and Approving Schedules of Rates, Schedules of Connection Fees, and Customer Notices issued in Docket No. W-218, Sub 573 on July 31, 2023. Under the new water usage rate, the average residential customer's monthly water bill will decrease by \$3.10, from \$139.70 to \$136.60, based on 5,000 gallons of usage.

The Public Staff – North Carolina Utilities Commission (Public Staff) presented this matter at the Commission's Staff Conference on September 18, 2023. The Public Staff stated that it had reviewed Pittsboro's rates and the Company's amended request and recommended that the Commission approve the tariff revision at the proposed rates for service rendered on and after the date of this Order and require customer notice.

Based upon the foregoing, the Commission finds that Aqua should be allowed to pass through the costs associated with the decreased purchased water expense.

IT IS, THEREFORE, ORDERED as follows:

1. That Aqua North Carolina, Inc., is granted a revision to Appendix A-2 of its tariff for water utility service in the Chapel Ridge, Laurel Ridge, and The Parks at Meadowview service areas in Chatham County in which it purchases and resells water from Pittsboro, as set forth herein;

2. That the revised Appendix A-2 attached hereto is approved and deemed filed with the Commission pursuant to N.C.G.S. § 62-138. This Schedule of Rates shall become effective for service rendered on and after the date of this Order; and

ORDER APPROVING TARIFF REVISION AND REQUIRING CUSTOMER NOTICE

BY THE COMMISSION: On August 9, 2023, Carolina Water Service, Inc. of North Carolina (CWSNC or Company) filed a verified petition with the North Carolina Utilities Commission (Commission) pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to its metered water customers in the Riverbend Estates service area in Macon County an increase in the cost of purchasing water service from the Town of Franklin. Section 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

CWSNC stated that, effective July 1, 2023, the Town of Franklin increased its usage charge for water service by \$0.60 per 1,000 gallons, increasing the rate from \$8.40 to \$9.00 per 1,000 gallons. CWSNC requested to increase its usage charge to its water customers in the Riverbend Estates service area for service rendered on and after July 1, 2023, to pass along this increase in the cost of purchasing water service from the Town of Franklin.

CWSNC's current usage rate related to its bulk purchased water service from the Town of Franklin became effective on September 7, 2022, upon issuance of the Commission's Order Approving Tariff Revision and Requiring Customer Notice in Docket W-354, Sub 408. CWSNC requested authority to increase its water usage rate from \$8.40 to \$9.00 per 1,000 gallons to reflect the increase in the cost of purchasing water service from Town of Franklin. The current monthly base facility charge for a <1" meter is \$27.49 pursuant to the Commission's Order Approving Schedules of Rates, Schedules of Connection Fees, and Customer Notices issued in Docket No. W-354, Sub 400 on May 12, 2023.

Under the new water usage rate, the average residential customer's monthly water bill will increase by \$2.38, from \$60.82 to \$63.20 based on 3,968 gallons of usage<sup>1</sup>.

The Public Staff – North Carolina Utilities Commission (Public Staff) presented this matter at the Commission's Staff Conference on September 18, 2023. The Public Staff stated that it had reviewed the Town of Franklin's rates and the Company's request and recommended that the Commission approve the tariff revision at the proposed rates for service rendered on and after the date of this order and require customer notice.

Based upon the foregoing, the Commission finds that CWSNC should be allowed to pass through the costs associated with the increased purchased water expense.

IT IS, THEREFORE, ORDERED as follows:

1. That Carolina Water Service, Inc. of North Carolina is granted a revision to Appendix C-1 of its tariff for water utility service in the Riverbend Estates service area in Macon County in which it purchases and resells water from the Town of Franklin, as set forth herein;

2. That the revised Appendix C-1, attached hereto, is approved and deemed filed with the Commission pursuant to N.C.G.S. § 62-138. This Schedule of Rates shall become effective for services rendered on and after the date of this Order; and

3. That the Notice to Customers, attached hereto as Appendix G-1 (RY 1), shall be mailed with sufficient postage or hand delivered by the Company to all its affected customers in the Riverbend Estates service area contemporaneously with the next billing of customers, and that the Company shall submit to the Commission the attached Certificate of Service, properly signed and notarized, no later than ten days after the date of the next billing.

Violations of the Sewer Use Rule may result in disconnection. Reconnection will require reimbursement of the Utility's actual costs incurred as a result of the violation. Repeat

violations may result in permanent disconnection.

As part of the Sewer Use Rule, the Utility may require installation and/or proper operation of grease traps or other pre-treatment devices on grease producing commercial facilities. Failure to properly operate grease traps will result in disconnection of service pursuant to Commission Rule R10-16.

The new water usage rate will increase the average residential monthly bill by \$2.38, from \$60.82 to \$63.20 based on an average usage of 3,968 gallons.

ORDER APPROVING TARIFF REVISION AND REQUIRING CUSTOMER NOTICE

BY THE COMMISSION: On July 19, 2023, Dillsboro Water Utilities, Inc. (Dillsboro) filed a letter with the North Carolina Utilities Commission (Commission) requesting authority to amend its tariff for the purpose of passing along to its water and sewer customers in the BP/Subway, Holiday Inn Express, Microtel, and Dillsboro Crossing Apartments service areas in Jackson County an increase in the cost of purchasing water and sewer service from Tuckaseigee Water and Sewer Authority (TWSA). On August 3, 2023, Dillsboro filed a verification pursuant to N.C. Gen. Stat. § 62-133.11. Section 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

Dillsboro stated that, effective July 1, 2023, TWSA increased the following rates for water service: the minimum monthly commercial charge by \$0.74, from \$23.36 to \$24.10; the usage charge for over 1,800 gallons of usage by \$0.11, from \$3.50 to \$3.61 per 1,000 gallons; the usage charge for over 50,000 gallons of usage by \$0.27, from \$3.61 to \$3.88 per 1,000 gallons; the usage charge for over 100,000 gallons of usage by \$0.38, from \$4.04 to \$4.42 per 1,000 gallons; and the system improvement charge by \$0.07, from \$1.37 to \$1.44 per 1,000 gallons. TWSA increased the following rates for sewer service: the minimum monthly commercial charge by \$1.71, from \$23.36 to \$25.07; the usage charge for over 1,800 gallons of usage by \$0.14, from \$3.50 to \$3.64 per 1,000 gallons; the usage charge for over 100,000 gallons of usage by \$0.12, from \$3.61 to \$3.73 per 1,000 gallons; the usage charge for over 100,000 gallons of usage by \$0.05, from \$4.04 to \$4.09 per 1,000 gallons; and the system improvement charge by \$0.09, from \$1.37 to \$1.46 per 1,000 gallons. Dillsboro requested to change its usage charge to its water and sewer customers in its BP/Subway, Holiday Inn Express, Microtel, and

Dillsboro Crossing Apartments service areas to pass along this increase in the cost of purchasing water and sewer service from TWSA.

Dillsboro's current water and sewer rates became effective on September 8, 2022, upon issuance of the Commission's Order Approving Tariff Revision and Requiring Customer Notice in Docket No. W-1327, Sub 2.

Per TWSA's Senior Customer Service Representative/Billing Coordinator, TWSA changed the water and sewer billing process for Dillsboro in April 2020. Prior to April 2020, TWSA was charging a minimum commercial water and sewer charge for a total of 20 units. The actual total units served by Dillsboro is 17, with four commercial units receiving both water and sewer service, and 13 residential units receiving only sewer service. Therefore, in order to reflect TWSA's new billing process for Dillsboro, the Public Staff recommended recalculating the sewer base facility charge.

The Public Staff presented this matter at the Commission's Staff Conference on September 18, 2023. The Public Staff stated that it had reviewed TWSA's rates, TWSA's new billing process for Dillsboro and the Company's request, and recommended that Dillsboro be allowed the following: increase its water usage rate by \$0.32, from \$4.96 to \$5.28 per 1,000 gallons; decrease its sewer usage rate by \$0.02, from \$5.32 to \$5.30 per 1,000 gallons; increase its flat rate charged to Dillsboro Crossing Apartments by \$312.36, from \$944.10 to \$1,256.46 per month; decrease its base charge per residential equivalent unit (REU) by \$5.76, from \$31.30 to \$25.54; decrease its BP/Subway base charge by \$408.93, from \$2,222.30 to \$1,813.37; and decrease its Microtel (formerly DRA Living Hotel) base charge by \$351.33, from \$1,909.30 to \$1,557.97. The Public Staff stated that the recommended tariff revisions better match the costs of purchased water and sewer services to the rates to be charged by Dillsboro to its customers.

The Public Staff recommended that the tariff revision be approved as modified and indicated that Dillsboro agrees with the Public Staff's recommended rates.

Based upon the foregoing, the Commission finds that Dillsboro should be allowed to pass through the costs associated with the increased purchased water and sewer expenses as recommended by the Public Staff.

IT IS, THEREFORE, ORDERED as follows:

1. That Dillsboro Water Utilities, Inc. is granted a tariff revision for water and sewer utility service in the BP/Subway, Holiday Inn Express, Microtel, and Dillsboro Crossing Apartments service areas in Jackson County, North Carolina in which it purchases and resells water and sewer service from Tuckaseigee Water and Sewer Authority, as set forth herein;

2. That the Schedule of Rates, attached as Appendix A, is hereby approved and is deemed filed with the Commission pursuant to N.C.G.S. § 62-138. This Schedule

of Rates shall become effective for service rendered on or after the date of this Order; and

3. That the Notice to Customers attached hereto as Appendix B shall be mailed with sufficient postage or hand delivered by Dillsboro Water Utilities, Inc. to all its affected customers in the BP/Subway, Holiday Inn Express, Microtel, and Dillsboro Crossing Apartments service areas contemporaneously with the next billing of customers, and that Dillsboro Water Utilities, Inc. shall submit to the Commission the attached Certificate of Service, properly signed and notarized, no later than ten days after the date of the next billing.
