The President of the Greater Kinnakeet Shores Homeowners, Inc., Pat Weston, at the suggestion of the Public Staff, has requested that we file on the Association's behalf letters from constituents within the Kinnakeet Shores service area expressing their desire that action be taken by the Commission in response to the petition filed in this docket seeking the Commission's assistance to lift the pending moratorium and provide other relief. Some of these letters provided the support for the Petition to Intervene filed March 11, 2022. Others have been received more recently.

The petition on behalf of the Homeowners Association has been pending since December 13, 2021. The petition sets forth the critical nature of the service issues in Kinnakeet Shores and requests expedited relief. In the meantime, loan rate locks have been extended, twice in some cases, and are now in jeopardy of expiring with no more extensions, resulting in thousands of additional dollars lost by property owners planning construction. The Homeowners Association continues to labor under extreme pressure from its constituents seeking relief from the deleterious effects of the moratorium and threats to service.

Pleadings on behalf of the Respondent and responses by the Petitioner thereto have been pending unaddressed since February 11, 2022.
