BY THE CHAIR: On August 17, 2021, the Commission issued an Order Approving SISC Avoidance Requirements and Addressing Solar-Plus-Storage Qualifying Facility Installations, which, among other things, directed Duke Energy Carolinas, LLC, and Duke Energy Progress, LLC (jointly, Duke) to file both 1) a comprehensive waiver request reflecting all waivers that are needed from the North Carolina Interconnection, in order to comply with the Commission’s directive to move ahead with an enrollment window for the ESS Retrofit Study Process; and 2) the procedure for how a QF establishes eligibility for the avoided cost rate or methodology applicable to the output of the energy storage addition. The Order also provided other parties the opportunity to comment on Duke’s filings and for Duke to file reply comments.

On September 13, 2021, Duke filed a Motion for Extension of Time to file the required compliance filing. The Commission granted the motion on September 14, 2021. Duke filed its compliance filing on this matter on September 22, 2021.

On October 14, 2021, the Carolinas Clean Energy Business Association (CCEBA) filed a Motion for Extension of Time. CCEBA stated that due to the press of other business before the Commission and the South Carolina Public Service Commission, it requests an extension of time for all parties to file comments on Duke’s compliance filing until on or before October 21, 2021. CCEBA also represents in its motion that Duke requests an extension to file reply comments until November 5, 2021. In its motion, CCEBA states that it requested consent for its motion from all parties of record in the above captioned dockets, and that no party objected the motion.

Based on CCEBA's Motion and the record as a whole, the Chair finds good cause to grant the extension. All parties may comment on Duke's filing on or before October 21, 2021. Duke may respond to those comments on or before November 5, 2021.

IT IS, THEREFORE, SO ORDERED.
