PUBLIC STAFF'S  
MOTION FOR SECOND  
EXTENSION OF TIME

NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission, by and through its Executive Director, Christopher J. Ayers, and respectfully requests the Commission to extend the time for the filing of a protest, petition for intervention or comments in the above-captioned docket to and including February 4, 2019. In support of this motion, the Public Staff shows as follows:

1. On December 18, 2018, Duke Energy Progress, LLC (DEP), filed its request for approval of proposed modifications to its Residential Smart Saver Energy Efficiency Program.

2. Rule R8-68(d)(2) provides that interested parties shall have 30 days from the date of the filing in which to intervene, file a protest, or file comments. The 30-day period for the instant application expires January 17, 2019.

3. On January 15, 2019, the Public Staff requested an extension of the date by which to intervene, file a protest, or file comments, which was granted by the Commission on the same day.

4. The Public Staff is continuing to review the response to its data request to DEP and to prepare its comments. Thus, the Public Staff requests that the Commission extend the deadline by which to intervene, file a protest, or file comments an additional ten days to February 4, 2019.

5. DEP has no objection to this request for extension of time.

THEREFORE, the Public Staff moves:

That the Commission grant the Public Staff and other intervenors an extension of time until the close of business on February 4, 2019, by which to intervene, file a protest, or file comments in this docket.
