NOW COMES the Office of the Attorney General (AGO), pursuant to Rule R1-7(a)(5) of the North Carolina Utilities Commission (Commission) and the *Order Requiring Filing of Supplemental Comments*, issued by the Commission on April 22, 2022, and subsequent orders granting motions for extension of time, respectfully move the Commission for a 30-day extension of time to October 7, 2022, for all parties to file supplemental reply comments. In support of its motion, the AGO shows as follows:

- 1. On April 22, 2022, the Commission issued an order directing the Companies, DENC and the Public Staff to file comments on the implementation of, and any updates to, the utilities' respective customer billing and data management systems, and the utilities advanced metering infrastructure, explaining how these developments inform or affect the parties previously filed comments.
- 2. The Order also encouraged, without requiring, other intervenors to file supplemental comments on these and any other relevant developments since the filing of past comments.

- 3. On July 22, 2022, the AGO, Duke Energy Carolinas, LLC, (DEC) Duke Energy Progress, LLC, (DEP) the Public Staff, Dominion Energy North Carolina (DENC), and Mission:Data filed Supplemental Comments. These supplemental comments included proposed changes by the AGO to the rules.
- 4. On August 4, 2022, Duke Energy Carolinas, LLC and Duke Energy Progress, LLC filed for an extension of time to file supplemental comments. The Commission granted that extension of time the following day, and the current deadline is September 7, 2022.
- 5. The AGO has met with other parties to see if agreement can be reached on the treatment of requests for disclosure of aggregated customer data and additional time is needed for further discussions.
 - 6. The requested extension will not result in prejudice to any party.
- 7. The undersigned has communicated with counsel for DEC, DEP, DENC, Public Staff, and Mission:Data about this requested extension, and no party has objected to it.

WHEREFORE, the AGO respectfully requests that the Commission issue an order granting an extension of 30 days, up to and including October 7, 2022, for all parties to file supplemental reply comments.
