- A. Yes, the Stipulation sets forth the full agreement of NRLP and the Public Staff.

- A. NRLP is in total support of and endorses the Stipulation and believes that the terms and conditions of the Stipulation are in the best interest of NRLP and its customers and urges the Commission to accept the Stipulation.
