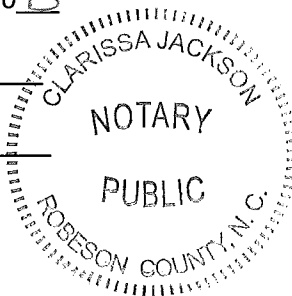

DOCKET NO. SP-5220, SUB 0 APPLICATION OF BLADEN SOLAR, LLC FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

NOTICE IS HEREBY GIVEN that on February 23, 2015, Bladen Solar, LLC (Applicant), filed an application seeking a certificate of public convenience and necessity pursuant to G.S. 62-110.1(a) for construction of a 50-MW solar generating facility to be located on the west side of Braxton Edge Road, west of the intersection with Old Fayetteville Road, and east of Walter West Road in Fayetteville, Bladen County, North Carolina. The Applicant plans to sell the electricity to Duke Energy Progress, Inc. Details of the application may be obtained from the Office of the Chief Clerk of the North Carolina Utilities Commission, 430 N. If a complaint is received within ten days after the last date of the publication of this notice, the Commission will schedule a public hearing to determine whether a certificate should be awarded, will give reasonable notice of the time and place of the hearing to the Applicant and to each complaining party, and will require the Applicant to publish notice of the hearing in this newspaper. If no complaint is received within the time specified above and if the Commission does not order a hearing upon its own initiative, the Commission will enter an order awarding the certificate sought by the Applicant.
