CONVENIENCE AND NECESSITY NOTICE IS HEREBY GIVEN that on February 23, 2015, Bladen Solar, LLC (Applicant), filed an application seeking a certificate of public convenience and necessity pursuant to G.S. 62-110.1(a) for construction of a 50-MW solar generating facility to be located on the west side ing facility to be located on the west side of Braxton Edge Road, west of the intersection with Old Fayetteville Road, and east of Walter West Road in Fayetteville, Bladen County, North Carolina. The Applicant plans to sell the electricity to Duke Energy Progress, Inc.
