NOW COMES Aqua North Carolina, Inc. ("Aqua"), and offers a commitment to supplement the Joint Motion for Extension of Time to File Proposed Orders.

1. The proposed orders of Aqua and the Public Staff – North Carolina Utilities Commission ("Public Staff") are currently due today, March 20, 2023, as provided in the Commission's February 16, 2023, order granting the Public Staff's motion for a four-week extension of time to file proposed orders and/or briefs. That order accepted Aqua's waiver of its right to implement its original proposed rates by operation of N.C.G.S. § 62-134(b) for a period of four weeks, corresponding to the four-week extension requested by the Public Staff.

2. On March 17, 2023, Aqua and the Public Staff filed a Joint Motion for Extension of Time to File Proposed Orders, seeking an additional eleven-day extension of time.

3. Aqua agrees to waive its right to seek to implement its original proposed rates by operation of N.C.G.S. § 62-134(b) for an additional eleven days beyond the waiver it made in conjunction with the extension of time granted on February 16, 2023. The additional eleven-day waiver corresponds to the eleven day extension requested jointly by the Public Staff and Aqua on March 17, 2023.

4. The Public Staff has no objection to this filing of a waiver of Aqua's time for implementing rates.

WHEREFORE, Aqua requests that the Commission accept this waiver commitment from Aqua when the Commission considers the March 17, 2023, Joint Motion for Extension of Time to File Proposed Orders.
