Re: Cancellation Notice for Certificate of Exemption Number C-3015 for
Failure to Attend Mandatory Maximum Rate Tariff (MRT) Seminar

Dear Mr. Rojas:

On June 8, 2022, in Docket No. T-4885, Sub 0, the North Carolina Utilities Commission (Commission) issued an Order Granting Application for Certificate of Exemption which authorizes your company, Supreme Movers, LLC, to transport households within and throughout the state of North Carolina. As you are aware, all newly Commission-certified movers are required to attend a Maximum Rate Tariff (MRT) Training Seminar no later than three (3) months from the date that their company is certificated. Please see Ordering Paragraph No. 5 of the June 8, 2022 Order. Free MRT Training Seminars are provided throughout the year as a joint effort by the Commission, the Public Staff Transportation Rates Division, and the North Carolina Movers Association.

The Commission has been informed by the Public Staff Transportation Rates Division that neither you nor any other representative of Supreme Movers, LLC, has attended any of the free monthly MRT Seminars held since the issuance of its certificate. The MRT Seminar is and has been offered online regularly since and prior to Supreme Movers, LLC, receiving its certificate of exemption.

In order to prevent the cancellation of your certificate of exemption to transport household goods, you are strongly encouraged to attend the next free online MRT Seminar. For the information regarding the seminar date and or to register for the online training seminar, email the Public Staff at Transportation@psncuc.nc.gov.

Furthermore, if you do not attend the next scheduled online MRT Seminar, you will leave the Commission no option but to issue an order canceling Certificate of Exemption Number C-3015 issued
